ORDINANCE IVO

AN ORDINANCE authorizing the construction of a wooden bridge on the Santiam Road over Pennywinkle Creek in the City of Albany, Oregon, providing for the payment of the cost thereof, and declaring an emergency.

WHEREAS, the Pennywinkle bridge on the Santian Road in the City of Albany, Oregon, is inadequate and unsafe for the accommodation of the traffic on said road, and

WHEHEAB, the Mayor and Council deem it expedient and necessary that a new bridge be constructed across said Pennywinkle Creek to replace the old bridge now in said location, and

WHEREAS, the Council has advertised for bids for the construction of a new bridge over said Pennywinkle Creek in accordance with the plans and specifications therefor, now on file in the office of the Recorder of said City, and has received bids for the work and material necessary for constructing said bridge, and

WHRHEAS, the Council has found that all bids received by it for the construction of said bridge are unreasonable max, and has accordingly rejected all bids so submitted, and

WHEREAS, the Mayor and Council deem it expedient that said bridge be constructed by said City by force account and in the manner provided by the charter in such cases made and provided;

THEREFORE THE PROPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That the Council of the City of Albany, 55, and it is hereby, authorized and directed to build and construct a wooden bridge across Penny-winkle Creek on Santiam Road in said City, in accordance with the plans and specifications of Charles H. Leonard, Engineer, now on file and of record in the office of the City secorder, which said plans and specifications have heretofore been duly adopted by the Council.

Section 2. That said bridge shall be constructed unier the supervision of Charles H. Leonard, hereby designated as the City Engineer of said City for eaid work, and said city by and through said Engineer shall have power and authority to purchase and hold utensils, machinery and material, or to hire or rent the same, and to hire and discharge servants and laborers, and to do any and all things necessary in the making of said improvement that a contractor might do. Said engineer shall keep an accurate account of all expenses, fully itemized, in making such improvement, and shall report the same to the Jouncil from time to time during the progress of the work, and upon the approval thereof by the Council the Recorder is hereby authorized and directed to draw warrants against the street fund of said city in payment of said items of expense so approved.

Section 3. Whereas the peace, health and safety of the people of the City of Albany require that this ordinance should become immediately effective, therefore an emergency is declared to exist, and this ordinance shall be in full force and effect immediately upon its final passage by the Council and approval by the Mayor.
