**ORDINANCE No. 1292**

AN ORDINANCE declaring a deficit of \$73.12 on account of the improvement of Second Street in the City of Albany, Oregon, from the east line of Oak Street to the west line of Pine Street under the contract of C.M. Davis for the making of said improvement, and directing the Recorder of said City to enter the record of such deficit in the proper lien docket.

THE PEOPLE OF THE <sup>CITY</sup> OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a deficit of \$73.12 is hereby declared on account of the improvement made by C.M. Davis on Second Street in the City of Albany, Oregon, from the east line of Oak Street to the west line of Pine Street, and the Recorder of the City of Albany is hereby directed to enter the record of such deficit in the proper lien docket the proportionate amount thereof hereby assessed and charged against the lots originally assessed and as follows, to-wit:


