

# ORDINANCE NO. 1208

AN ORDINANCE levying a tax for the City of Albany, Oregon, upon the current assessment made upon the taxable property of the City for the year 1928, for taxes to become due and payable in the year 1929, and to separately appropriate for each officer, department, building, structure, institution, bridges, streets and highways, parks and other purposes the amount of the taxes so levied.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That the Council of the City of Albany, Oregon, does hereby make, determine, declare and levy the amount of taxes in and for said City, based upon the current assessment made upon the taxable property therein for the year 1928, said taxes to become due and payable in the year 1929 in sums as follows, to-wit:

Section 2. That from the funds derived from the levy hereby made and determined, there is hereby appropriated for the year 1929 the sums set opposite the respective items as in Section 1 hereinbefore set forth.

Section 3. The Recorder of the City of Albany is hereby directed to immediately notify the County Clerk and County Assessor of Linn County, Oregon, of this levy as provided by law.
