ORDINANCE NO. 1311

AN ORDINANCE authorizing the Mayor and Council of the City of Albany, Oregon to purchase certain real property from Samuel J. Burch and Cora Burch, his wife, for Municipal Airport and/or airplane landing field purposes; appropriating the sum of Three Thousand One Mundred Fifty Dollars (\$3150.00) of the funds derived from the sale of the bonds of the City of Albany authorized by Chapter XI of the charter of said City in payment thereof and authorizing the Recorder to draw a warrant on said fund payable to the said Samuel J. Burch and Cora Burch in the sum of Three Thousand One Hundred Fifty Dollars (\$3150.00) in payment of said supposes price ment of said purghase price.

THE PROPIR OF THE CITY OF ALBANY OREGON DO ORDAIN AS FOLLOWS:

Section 1. The Mayor and Council of the City of Albany, Oregon, are hereby authorized and directed to purchase of Sasuel J. Burch and Cora Burch his wife the following described real property to be used as a municipal Airport and/or airplane landing field, to-wit:

Beginning at a point 25 feet east from the northwest corner of the Beginning at a point 25 feet east from the northwest corner of the D.L.C. of Jesse B. Parrish and wife, in Section 4, Township 11 south of range 3 west of the Willamette Meridian, in Linn County, Oregon, and running thence east 19.75 chains to a point 35.50 chains west of the east line of eaid D.L.C., thence south 10.55 chains to the north line of the right of way of the Corvallis and Kastern Railroad Company; thence southerly on the north line of said right of way to a point 25 feet east of the west line of said D.L.C.; thence north 10°38° west 17.47 chains to the place of beginning, containing 31.42 acres all lying and being situated in Linn County, Oregon.

Section 2. That there be and is hereby appropriated from the funds derived from the sale of the bonds of said City authorized by Chapter XI of the charter of the City of Albany, the sum of Three Thousand One Hundred Fifty Dollars (\$3150.00) in payment of the purchase price of the real property described in Section 1 hereaf, and the Recorder is hereby authorized and directed to draw a warrant on said fund payable to the said Samuel J. Burch and Corn Euroh in the sum of Three Thousand One Hundred Fifty Dollars (\$3150.00) and to deliver the same to them upon their delivery to the City of Albany a good and sufficient deed conveying said described premises at said City of Albany accompanied by an abstract of title thereto showing themselves to be possessed of a fee simple title thereto free of incumbrances. brances.
