

ORDINANCE NO. 1117

An ordinance levying a tax for the City of Albany, Oregon, upon the current assessment made upon the taxable property of said City for the year 1930, for taxes to become due and payable in the year 1931, and to separately appropriate for each officer, department, building, structure, institution, bridges, streets and highways, and parks and other purposes the amount of the taxes so levied.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That the Council of the City of Albany, Oregon, does hereby make, determine, declare and levy the amount of taxes in and for said City, based upon the current assessment made on the taxable property therein for the year 1930, said taxes to become due and payable in the year 1931 in sums as follows, to-wit:
