

# ORDINANCE No. 1340

An ordinance declaring a surplus on account of the improvement by D.L.Ashton of Park Terrace Street from the south line of Clackamas Street to the north line of Fifteenth Street, in the City of Albany, Oregon, and directing the Recorder of said City to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed and entered of record, in the docket of City Liens, in the City of Albany, Oregon, for making such improvement, their proportionate share of such surplus;

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$109.74 is hereby ascertained and declared to exist upon the completion of the contract entered into between the City of Albany, Oregon, and D.L.Ashton, for the improvement of Park Terrace Street, from the south line of Clackamas Street to the north line of Fifteenth Street, in said City, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for making such improvement.

Section 2. The Recorder of the City of Albany, Oregon, is hereby directed to enter in the docket of City Liens, in the surplus column thereof, the sum of \$109.74, based on the several amounts heretofore assessed and entered therein to defray the cost of improving said street, said surplus being in favor of the following named persons, owners, or reputed owners, of the various parcels of real estate, and in the sums as follows, to-wit:
