ORDINANCE NO 1849

An ordinance to secertain and determine the probable cost of the improvement which the Council of the City of Albany, Oregon, has determined to make in and by ResolutionNo. 35, adopted by the Council on the 11th day of March, 1931, on Righth Street, in said City, from the east line of Ellsworth Street to the west line of Lyon Street, except a strip 36 feet wide, being \$8 feet on each side of the center line of said portion of said street, and extending the full length of the improvement; to ascertain, assess, determine and declare the proportionate share of such probable cost of such improvement of said Righth Street that is assessed upon each let or part thereof adjacent to said portion of Righth Street to be so improved; to authorize and direct the Recorder of shiddity to enter a statement of such assessment in the Docket of City Liens as provided by the charter of said City. City.

WHEREAS, on the 11th day of March, 1931, the Council of the City of Albany, Orewhereas, on the lith day of march, 1931, the Council of the City of Albany, Con, duly adopted a resolution requiring Charles H. Leonard, engineer, to prepare and file in the office of the necorder of said City on the 25th day of March, 1931, plans, specifications and estimates of the probable cost of making the improvement of Eighth Street in said City from the east line of Ellsworth Street to the west line of Lyon Street, with a suitable hard surface pavement to be slected and approved by the Council; and

WHEREAS, said Engineer, pursuant to said resolution made plans, specifications and estimates as directed thereby for the improvement of said Eighth Street, and filed the same in the office of the Recorder of said City on the 25th day of March.

1931; and

WHERAS, the Council of said City on the 25th day of March, by Resolution No. 35, duly adopted by said Council, determined and resolved that it deemed it expedient and that the Council proposed to improve Righth Street from the east line of Ellsworth Street to the west line of Lyon Street in the City of Albany, Oregon, in the manner provided in and Resolution He 12. in the manner provided in said Resolution No. 35, and

WHERAS, in and by said resolution No. 35, adopted as aforesaid by the Council, the Recorder of said City was duly ordered and directed to give notice of said propesed imprevement of said Righth Street from the east line of Ellsworth Street to the west line of Lyon Street, in the City of Albany, as provided by the charter

and ordinances of said City, and

WHENEAS, the Recorder in pursuance of said order and direction of the Council of said City of Albany, did duly give notice of said proposed improvement of said Bighth Street in the manner provided by said resolution and the charter and ordi-

nances of said City, and

WHEREAS, the Council in and by said Resolution No. 35 ascertained and determined the total probable cost of making said improvement of said Eighth Street to be paid by the owners of the real property adjacent to said portion of said Righth Street to be improved as specified in said resolution No. 35 to be the sum of \$1452,50, and

WHERAS, by Ordinance No.1346 after due notice for the time and in the manner provided by law the bid of Dent F. Stewart for making of said improvement of said portion of Eighth Street was accepted and the Mayor and Hecorder of the City of Albany were thereby authorized to enter into a contract with Dent F. Stewart for the making of said improvement in accordance with said bid with Portland cement concrete pavement and in other respects in accordance with said Resolution No. 35.

THEREFORE. THE PROPER OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That Righth Street, in the City of Albany, from the east line of Allsworth Street to the weet line of Lyon Street, except a strip 36 feet wide, being 18 feet on each side of the center line of said portion of said street

and extending the full length of the improvement shall be improved as follows:

let: By grading said portion of said street to the proper sub-grade;

2nd: By paving the roadway of said portion of said street (according to plans and specifications) with Portland cement concrete pavement.

3rd: By laying and constructing pavement headers.

4th: By constructing concrete curbs wherever necessary;

5th: By constructing catch basins and inlete; 6th: By laying vitrified sewer pipes;

all in accordance with eaid Resolution No. 35, and the plans and specifications antesextifications for said improvement filed by Charles H. Leonard, City Engineer, with the Recorder of said City of Albany, on the 25th day of March, 1931.

Section 2. That the probable cost of making said improvement of said Eighth Street from the east line of Rlisworth Street to the west line of Lyon Street in said City, in the manner heretofore determined mby the Council of said City, and in and by said Resolution No. 35 to be paid by the owners of the real property adjacent to eaid portion of Righth Street is hereby declared to be the sum of \$1452.50.

Section 3. That the proportionate share of said probable cost of said improvement of said Eighth Street assessed upon each lot, or part thereof, adjacent to said portion of Eighth Street to be improved as aforesaid and as determined by said Council and in and by said Resolution No. 35, is hereby ascertained and declared to be the sum set and placed immediately after the separate description

of each of such lots, or parts thereof, as follows:

DORA BUSSAND: The south 60 feet of the southwest quarter of Block 51
in the City of Albany, Oregon
L.G.LEWRLLING: The south 55% feet of the southeast quarter and west \$363.12

50 feet of the north helf of the southeast quarter of Block 81 in the City of Albany, Oregon
P.M.IRICON: The northwest quarter of Block 70 in the City of Albany, \$363.12 Oregon B.R.KMOSCHMIL: The northeast quarter of Block 70 in the City of 363.12 Albany, Oregon 363,12

Section 4. That the Recorder of the City of Albany, Oregon, is hereby ordered and directed to immediately enter a statement of the assessments hereby made and declared by this ordinance, together with the numes of the respective owners of each lot or part thereof hereinabove described in the Docket of City Liens in the City of Albany, as provided by the charter of said City.
