

**ORDINANCE No. 1349**

An ordinance declaring a surplus on account of the improvement made by Dent F. Stewart of Eighth Street from the east line of Ellsworth Street to the west line of Lyon Street, except a strip 36 feet wide, being 18 feet on each side of the center line of said portion of said street and extending the full length of the improvement, in the city of Albany, Oregon, and directing the Recorder of said City to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement assessed and entered of record in the Docket of City Liens in the City of Albany, for the making of such improvement, their proportionate share of such surplus.

THE PEOPLE OF THE CITY OF ALBANY, OREGON, DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$191.35 is hereby ascertained and declared to exist upon the completion of the contract entered into between the City of Albany, Oregon, and Dent F Stewart for the improvement of Eighth Street from the east line of Ellsworth Street to the west line of Lyon Street except a strip 36 feet wide, being 18 feet on each side of the center line of said portion of said street and extending the full length of the improvement in said City and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany, Oregon, is hereby directed to enter in the docket of City Liens, in the surplus column thereof, the sum of \$191.35, based upon the several amounts heretofore assessed and entered therein to defray the cost of improving said street, said surplus being in favor of the following named persons, owners, or reputed owners, of the various parcels of real estate and in the sum as follows, to-wit:

BUSSARD, DORA.--The south 60 feet of the southwest quarter of block 51, in the City of Albany, Oregon	Surplus	\$47.84
LEWELLING, L.G.--The south 53 1/2 feet of the southeast quarter and the west 50 feet of the north half of the southeast quarter of block 51, in the City of Albany, Oregon	Surplus	47.83
LEMMON, P.H.--The northwest quarter of block 70, in the City of Albany, Oregon	Surplus	47.84
KROSCHELL, E.R.--The northeast quarter of block 70, in the City of Albany, Oregon.


