ORDINANCE NO 1561

An ordinance to regulate the operation of tank wagons or vehicles engaged in the transportation or distribution of volatile or inflammable fluide or liquids within the corporate limits of Albany, Oragon.

THE PROPLE OF THE LITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. It shall be unlawful for any tank wagons or vehicles, engaged or used in the transportation or distribution of any volatile or inflammable fluid or liquid, to be parked in any place within the fire limits of Albany, except for the purpose of discharge or delivery of cargoes, and it is unlawful for any vehicle, emgaged or used in the transporation of any such volatile or inflammable fluid or liquor to park or to be parked in any other section of the City of Albany at any time for a longer period than thirty minutes.

Section 2. It shall be unlawful at any time to operate, propel or tew as a trailer any tank wagons or vehicles within the city limits of Albany, enged or used in the transporation or distribution of volatile or inflammable fluids or liquids, any part of the equipment or appurtenance thereof being in a condition which permits of the leaking, splashing, sloshing or overflowing of the said volatile or inflammable fluid or liquid contents of such vehicle or container thereof which constitutes a hezard to life or property from fire or explosion.

Section 3. All tank wagons or vehicles when used for transportation or distribution of volatile or inflammable fluids or liquids, shall be of substantial and workmanlike construction and shall be subject to the approval of the chief of the fire department, who shall inspect and keep a record of such tank wagons or vehicles, which tank wagons or vehicles shall be plainly marked with a record serial number, letter or symbol for the purpose of identification. All faucets connected to such tank wagons or yahicles shall be kept locked or have handle removed when not in actual use, high handle to be so constructed that it may not be removed grown when the faucet is tightly constructed that it may not be removed except when the faucet is tightly closed, and all measures and faucets shall be covered or otherwise protected.

Section 4. All such tank wagons or vehicles shall be properly grounded when provided with rubber tires or other non-conductive materials, with a metal chain or other equally conductive device or equipment, to carry off any friction or static spark which may be generated. In the event that wood or other cushion or shock absorbing material be used in the construction of such tank wagons or vehicles, the metal parts thereof shall be properly and safely bonded and grounded for the safe conduct of static electricity so as to preclude the possibility of fire or explosion.

Section 5, Any person or persons found guilty of the violation of the provisions of this ordinance shall be punished by a fine of not to exceed twenty-five (CC5.00) dollars or imprisonment for not to exceed ten (10) days for each and every act in violation of the provisions hereof, or by such fine and imprisonment.

Section 6. Whereas, the peace, health and safety of the City of Albany require that this ordinance thall be immediately effective.

Therefore, an emergency is hereby technical to exist, and this ordinance

shall become immediately effective/ upon its final passage by the Council and approval by the Mayor.
