

ORDINANCE NO. 1385

An ordinance levying a tax for the City of Albany, Oregon, upon the current assessment made upon the taxable property within said City for the year 1931, for taxes to become due and payable in the year 1932, and to separately appropriate for each department, officers, buildings, structures, institutions, bridges, streets, and highways and parks, and other purposes, the amount of the taxes so levied.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That the levy of the amount of taxes in and for the City of Albany, Oregon, based upon the current assessment made upon the taxable property therein for the year 1931 for taxes to become due and payable in the year 1932, is hereby made, determined and declared, to be as follows; wto-wit:
