ORDINANCE NO. 1868

An ordinance to appropriate the sum of \$1407.35 of the funds heretofore set aside in the emergency fund of the City of Albany, Oregon, and to expend the same for the purpose of paying for the power used in Max lighting the streets, alleys and other public places in the City of Albany, Oregon, as per the current bills rendered said city for such purposes by the Mountain States Power Company, the amount of such bills being in excess of the amount heretofore appropriated for such purposes; authorizing the "ecorder of the Jity of Albany, Oregon, to draw warrants against the General Fund payable to eaid Mountain States Power Company aggregating the amount hereby appropriated and declaring an emergency. gency.

WHRHKAS, funds have heretofore been appropriated by the City of Albany,

the lighting of the City Streets, alleys and other public places in said City, for the year 1931, amounting to the sum of \$9500.00; and WHENEAS, the notual cost of lighting the city streets, alleys and other public places in eaid City for the year 1931, aggregate the sum of \$10907.35, thus overdrawing said appropriation in the sum of \$1407.35; and

WHENKAS, there is now on hands in the general funds heretofore appropriated as an emergency fund the balance of which said unexpended is now in excess of the deficiency required for street lighting purposes as aforesaid.

THEREFORE. THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That there be and is hereby appropriated from the general funds of the City of Albany, Oregon, from the division thereof heretofore set aside, senths Emergency Fund the sum of \$1407.35 for the purpose of paying the current bills now due the Mountain States Power Company for furnishing the power for the lighting of the streets, alleys and other public places in the city of Albany, Oregon, in the year 1931, and the Recorder of saidCity is hereby authorised and directed to draw warrants against the general fund of said City payable to said Mountain States Power Company aggregating \$1407.35 in payment of the bills aforesaid.

Section 2. VHEREAS, the peace, health and safety of the City of Albany, and of the inhabitants thereof, require that this ordinance shall become immediately effective upon its final passage by the Council and approval by the

THEREFORE, it is hereby declared that by reason of the premises herein and of the facts disclosed by this ordinance an emergency is hereby declared to exist and this ordinance shall become immediately effective upon its final passage by the Council and approval by the Mayor.
