ORDINANCE NO. 1376

AW ORDINANCE to meend Section 10 of Ordinance No. 1371 of the City of Albany, Oregon entitled "A ardinance to license, tax, regulate and restrain, the manufacture, sale and/or disposal of alcoholic beverages within the City of Albany, Line County, Oregon; defining what shall constitute alcoholic of allowing prohibiting the manufacture, sale ani/or disposal thereof without a license, providing a penalty for violation hereof and declaring an energency," passed by the Council April 12, 1933 and approved by the Mayor April 12, 1933.

THE PROPLE OF THE ITY OF ALEANY . MICHURIA CASUFOLIOUSS:

Section 1. That Section 10.of Ordinance No. 1371 of the City of Albany, Oregon, entitled "An ordinance to license, tax, regulate and restrain the Manufacture, sale and/or disposal of alcoholic beverages within the City of Albany, Linn County, Oregon,; defining hivat shall constitute alcoholic beverages; pro-hibiting the manufacture, sale and/or disposale thereof without a license; providing a penalty for violation hereof and declaring an emergency, " passed by the Council April 12, 1933 and approved by the Mayor April 12, 1933, be and the same is hereby amended to read as follows: Section 10, Before obtaining a license to handle alboholic beverages under the provisions of this ordinance each applicant shall pay to the recorder of the Jity of Albany, Oregon, a license fee as follows:

3500.00 per annum, 25.00 per annum, Manufacturer. Wholesaler, Retailer, 15.00 per annum, Restaurant keeper, 25.00 per annum, Dispenser, 25.00 per annum.

A restaurant keeper operating a hotel in connection therewith shall pay a

A restaurant keeper operating a noted in connection therewith shall pay a license fee of \$20.00 per annum.

The above license fees are hereby made applicable for all licenses issued for the period beginning July 1st, 1933, and thereafter, and may be paid in semi-annual installments, providing that the same shall always be paid in advance, and if not so paid the license shall then become immediately null and void and no further effect without any further action or proceedings on the part

of the City of Albany.

For the purpose of this license the license year shall be livided into halves as follows: the first half extending from midnight December 31st to midnight June 30th, next following, and each license granted becember shall be issued so as to expire at midnight of the 30th of Jube, or midnight od the 31st of December. A fispenser herein mentioned shall be considered to be any licensee handling alcoholic beverages at retail, either in packages, or in open containers for consumption on the premises of such licensee, except a dispenser, restaurant keeper or hotel keeper, duly licensed shall sell or otherwise dispose of alcoholic beverages in open containers, or suffer or permit the same to be consumed on the premises of such licensee.
