

ORDINANCE NO. 1382

AN ORDINANCE levying a tax for the City of Albany, Oregon, upon the current assessment made upon the taxable property of said City for the year 1934 for taxes to become due and payable in the year 1935, and to separately appropriate for each officer, department, building, institution, streets, highways, sewers, parks and other purposes, the amount of taxes so levied.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That there is hereby made, determined, declared and levied, taxes in and for the City of Albany, Oregon, based upon the current assessment made upon the taxable property therein for the year 1934, said taxes to become due and payable in the year 1935, in sums as follows, to-wit:

Section 3. The Recorder of the City of Albany is hereby directed to immediately notify the County Clerk and County Assessor of Linn, Oregon, of the levy hereby made as provided by law.
