## ORDINANCE NO. 1486

AN CRDICANCE providing for the time and manner of building and constructing a lateral sewer as follows:

Project 1. Beginning at the main sewer on Takenah Street where the North line of Block 3 in Linnont addition to the City of Albany, Oregon, if extended Easterly, would intersect said main, and running thence Westerly along the North line of said Plock to the Northwest corner thereof.

Project 2. Beginning at the West and of the lateral sewer on the center line of Block 4 in Linmont Addition to the City of Albany, Oregon, and running thence Westerly along the center line of said Block to the West line the reof.

Project 3. Deginning at a point where the South line of Block 5 in Linmont Addition to the City of albany, Ore on, would intersect the main sewer on Takenah Street, and running thence Westerly along the South line of said Block to the West line thereof; and

providing how the cost of said improvement shall be paid; the penalty and damage to the City of Albany by the person or persons making said improvement if the same be not completed at the tire agreed upon; the giving of a good and sufficient bend for the performance of the work of said improvement and providing for the giving of notice for bids for the taking of said improvement by the Recorder of the City of Albany, regon.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That there shall be constructed an 8 inch vitrified terra cotta sewer pipe an follows:

Project 1. Beginning at the main sewer on Takenah Street where the North line of Block 3 in Linmont addition to the Pity of albany, Gregon, if Extended Easterly, would intersect said main, and running thence Westerly along the forth line of said block to the Northwest corner thereof.

Project 2. Beginning at the West end of the lateral sewer on the center line of Block 4 in Limmont addition to the City of albany, Oregon, and running thence Westerly along the center line of said Block to the West line thereof.

Project 3. Peginning at a point where the South line of Block 5 in Linmont addition to the City of Albany, Cregon, would intersect the main sewer on Takenah Street, and running thence Westerly along the South line of said Plock to the West line thereof.

Said improvement shall be hade in accordance with the Charter and Ordinances of the City of Albany, Oregon, and the plans and specifications of the City Engineer of said City for the construction of said lateral sewer filed in the office of the Recorder of the City of Albany, on the 11th day of November 1939.

The cost of said lateral sewer shall be paid out of the funds collected and arising out of the assessment to be made, ascertained and declared by the Council of the City of Albeny, on the lots and parts of lots adjacent to said improvement so to be made and especially and particularly benefited thereby as provided by the Charter of said City.

Said sewer shall be completed by the first day of June 1940.

All bids submitted for the making of said improvement deemed unreasonable by the Council of the City of Albany, may be rejected.

any firm, person or corporation with whom any contract may be entered into by the City for the making of said improvement shall before cormencing said improvement and at the time of filing such contract make, execute and deliver to said City a good and sufficient bond with good and sufficient surety to be approved by the wall or of the City of Albany, Oregon, in a sum equal to fifty percent of the amount to be paid for the faithful performance of said contract.

Section 2. If the firm, person or corporation entering into any co tract with the City of albany to take said improvement shall not complete the same within the time mentioned and specified in said contract, said City shall be desired to suffer damages on account thereof to the amount of \$5.00 per day for each and every day the completion of said work is delayed beyond the time so stated in said contract, which amount shall by paid by such contractor doing the work at the completion thereof unless the time for the completion thereof be extended by the Council.

Section 3. The Recorder of the City of Albany, Oregon, in hereby directed to immediately give proper notice of bids for the making of such improvement by publication of such notice for tendays in the Albany Democrat Herald, a daily newspaper published in the Gity of Albany, Oregon, describing in such notice the improvement to be made and the time and manner of doing same.
