A BILL FOR:

AN OPDIMANCE Poviding for the time and manner of improving Instilla Street from the north line of Fifteenth Street to the north line of Klamath Street and from the north line of Fiftsenth Street to the north line of Klamath Street and Klamath Street from the west line of Tmatilla Street to the Tast line of Takena Street in the Sity of albany, Cregon providing how the cost of such improvement shall be paid, the penalty or damage to the City of Albany by the person or persons making such improvement if the same shall not be completed on the time agreed upon, and the giving of a good and sufficient bond for the faithful performance of the work of such improvement, and providing for the giving by the Recorder of said City of notice for bids for the completion of said improvement.

THE PEOPLE OF THE CITY OF ALBANY DO OFDAIN AS FOLIOMS:

Section 1. That Umatilla Street from the north line of Fifteenth Street to the north line of Klamath Street and Klamath Street from the West line of Umatilla Street to the East line of Takena Street shall be improved in the following manner: to-wit:

By grading said Streets to the proper subgrade.
By paving the same with oil mat surface pavenent.
By installing concrete gutters, curbs and sidewalks, wherever necessary.

Said improvement shall be made in accordance with the Charter and Ordinances of the City of albany, Cregon, and the plans, specifications and estimates of Walter W. Larsen, Engineer, for the improvement of said street filed in the office of the Recorder of said City of albany on the 10th day of April, 1946.

The cost of the making of said improvement shall be paid out of the funds to be collected and arising upon and out of the assessments hereafter to be made, ascertained and declared by the Council of the City of all any on the lots and parts of lots adjacent to said portion of said Street so to be improved as hereinabove described and specially and particularly benefited thereby, as provided by the charter of said Wity of albany.

Said improvement shall be completed by the lat day of October, 1946.

All bids for the making of said incrovement deemed unreasonable by the Council may be rejected.

Any person, firm or corporation with whom'eny contract may be entered into by the "ity of albeny for the making of said improvement shall, before commencing said improvement and at the time of signing such contract, make execute and deliver to said City a g od and sufficient bond with sufficient surety thereon to be approved by the Mayor of the City of albany in a sum equal to fifty percent of the amount to be paid under such contract for the faithful performance thereof.

Saction 2. If the person, firm or corporation entering into any contract with the city of albany to make said improvement shall not complete the same with in the time mentioned and specified in such contract, the city of albany shall be deemed to suffer damages on account thereof in the amount of \$25.00 per day for each and every day the completion of said work is delayed be and the time stated in such contract, which amount shall be said by such contractor doing the work at the completion thereof unless the time of the completion of said improvement be extended by the council. by the vouncil.

Section 3. The Recorder of the City of Albany is hereby ordered and direct; a to immediately give proper notice for bids for making of said improvement by publishing such notice ten days in the Albany Democrat hereld, a newspaper of general circulation published in the City of Albany, fully describing in said notice the time and manner of doing said work of improving said portion of said street.
