

ORDINANCE NO. 125

A BILL FOR:

AN ORDINANCE to ascertain, assess, determine and declare the proportionate share of the probable cost that is assessed upon the lots or parts thereof or parcels or tracts of land adjacent to and for the construction of the following lateral sewers within the City of Albany, to-wit:

HACKLEMAN STREET LATERALS:

No. 1 Beginning at the manhole in the Hackleman Street Main sewer and running thence northerly through the center of Block 6 and 7 in Winona Park Add. to the City of Albany, Linn County, Oregon, a distance of 470 ft.

No. 2 Beginning at the manhole in the Hackleman Street Main Sewer, and running thence northerly through the center of Blocks 5 and 8 in Winona Park Add. to the City of Albany, Linn County, Oregon, a distance of 680 ft.

No. 3 Beginning at the manhole in the Hackleman Street Main sewer, and running thence northerly through Blocks 4 and 9 in Winona Park Addition to the City of Albany, Linn County, Oregon, a distance of 548 ft.

No. 4 Beginning at the manhole in the Hackleman Street Main Sewer, and running thence northerly through the center of Block 3 in Winona Park Addition to the City of Albany, Linn County, Oregon, a distance of 366. ft.

No. 5 Beginning at the manhole in the Hackleman Street Main Sewer, and running thence northerly through the center of Block 2 in Winona Park Addition to the City of Albany, Linn County, Oregon, a distance of 324 ft.

No. 6 Beginning at the manhole in the Hackleman Street Main Sewer, and running thence northerly through the center of Block 1 in Winona Park Addition to the City of Albany, Linn County, Oregon, a distance of 160 ft.

No. 7 Beginning at the manhole in the Hackleman St. Main Sewer and running thence southerly through the center of Bls. 5, 4 and 3 in Hackleman's Sunrise Add. to the City of Albany, Linn County, Oregon, a dis. of 1203 ft.

No. 8 Beginning at the manhole in the Hackleman Street Main Sewer and running thence southerly along the east line of Blocks 6,7, 8 and 9 in Hackleman's Sunrise Add. to the City of Albany, Linn County, Oregon, a distance of 1180 feet, together with sub-laterals connected therewith and running easterly as follows:

- (a) Through Block 1 of the Epauline Add. a dis. of 130 ft.
- (b) Through blocks 6,5,4, of the Epauline Add. a dis. of 607 ft.
- (c) Through Blocks 7,8,9, of the Epauline Add. a dis. of 607 ft.
- (d) Through Blocks 12, 11 & 10 of the Epauline Add. a dis. of 607 ft.
- (e) Through blocks 13,14,& 15 of the Epauline Add. a dis. of 607 ft.

Making a total distance of 4104 lineal feet.

Also beginning at the manhole on the Hackleman Street Main Sewer midway between Fremont and Hood Streets and running thence southerly through Block 2 in the Epauline Add. to the City of Albany, Linn County, Oregon, a distance of 180 feet.

Also beginning at the manhole on the Hackleman Street Main Sewer a distance of 53.75 feet west of the west line of Lafayette St. and running southerly through Block 2 in the Epauline Add. to the City of Albany, Linn County, Oregon, a distance of 180 feet.

No. 9 Beginning at the manhole in the Hill Street Main Sewer and running thence easterly through the center of Block 1 in Price's Add. to the City of Albany, Linn County, Oregon, a distance of 391 feet.

No. 10 Beginning at the manhole in the Hill Street Main Sewer 88.2 feet south of the south line of 10th street in Price's Add. to the City of Albany, Linn County, Oregon and running thence easterly a distance of 757 feet, together with sub-laterals connected therewith and running southerly in Hackleman's Grove Add. to the City of Albany, Linn County, Oregon, as follows:

- (a) Through the center of Block 1 of said Add. a distance of 264 ft.
- (b) Through the center of Blocks 2 & 3 of said Add. a distance of 250 ft.
- (c) From the east end of the lateral sewer above described thence southerly a distance of 188 feet.

No. 11 Beginning at the manhole in the Hackleman Street Main Sewer and running thence northerly along the center line of a 30 foot street through Block 1, in Oak Grove Acres, to the City of Albany, Linn County, Oregon, a distance of 214 feet.

No. 12 Beginning at the manhole at the south end of Main Sewer on Sherman Street in Oak Grove Acres and running thence west along the south line of Lots 1, 2, and 3 in Block 2 in said Oak Grove Acres, to the City of Albany, Linn County, Oregon, a distance of 206 feet.

Also beginning at the northwest corner of lot 34 in said Block 2, thence southerly through the center of said Block 2 a distance of 1050 feet to the north line of lot 19 in said Block and running thence easterly 48 feet, and also westerly 50 feet.

No. 13 Beginning at the manhole at the south end of Main Sewer on Sherman Street in Oak Grove Acres and running thence southerly along Sherman Street a distance of 450 feet, thence easterly along the south line of Lot 17 in Block 3 in said Oak Grove Acres, to the City of Albany, Linn County, Oregon, a distance of 90 feet, thence southerly through said Block 3 a distance of 725 feet, also beginning at the northeast corner of lot 4 in said Block and running westerly along the south line of lot 2 in said Block a distance of 90 feet.

COLUMBUS STREET LATERALS:

No. 1 Beginning at the manhole on Columbus Street main sewer between Willamette and Front Streets and running thence westerly through the center of Block 16 in Burkhart Park Add., to the City of Albany, Linn County, Oregon, a distance of 382 feet.

Also, beginning at the same point and running easterly through the center of Blocks 21 and 25 in Burkhart Park Add. to the City of Albany, Linn County Oregon, a distance of 1214 feet.

No. 2 Beginning at the manhole on Columbus Street Main Sewer between Front and Water Streets and running westerly through the center of Block 15 Burkhart Park Add. to the City of Albany, Linn County, Oregon, a distance of 382 ft.

Also, beginning at the same point and running easterly through the center of Blocks 22 and 24 in Burkhart Park Add. to the City of Albany, Linn County, Oregon, a distance of 949 feet.

No. 3 Beginning at the manhole on Columbus Street Main Sewer between Water and First Street and running westerly through the center of Block 14, Burkhart Park Add. to the City of Albany, Linn County, Oregon, a distance of 382 feet.

Also, beginning at the same point and running easterly through the center of Block 23, Burkhart Park Add. to the City of Albany, Linn County, Oregon, a distance of 219 feet.

OLD PACIFIC HIGHWAY LATERALS:

No. 1 Beginning at the manhole in the Old Pacific Hwy. Sewer near the northwest corner of Block 1 in Motleys Add. to the City of Albany, Linn County, Oregon, and running thence southerly along the west line of said Block and the east line of Block 4 in Burkharts Add. to the City of Albany, Linn County, Oregon, a distance of 1096 feet.

Also beginning at the southeast corner of Lot 16, Block 4, of said Add. and running thence easterly a distance of 200 feet.

No. 2 Beginning at the manhole in the Old Pacific Hwy. Main Sewer near the northwest corner of Lot 7 in Block 1, R. L. Burkharts Add. to the City of Albany, Linn County, Oregon, and running thence southerly through said Block 1, in said Add. to the south line thereof a distance of 450 feet.

Also, beginning at the southwest corner of Lot 7 in said Block 1 and running westerly a distance of 120 feet.

No. 3 Beginning at the manhole in the Old Pac. Hwy. Main Sewer near the northeast corner of Lot 3, Bl. 1, in Burkharts Add. to the City of Albany, Linn County, Ore., and running thence southerly a distance of 165 feet.

NEW PACIFIC HIGHWAY LATERS:

No. 1 Beginning at the manhole in the New Pacific Hwy. Main sewer near the northeast corner of Lot 1, Bl. 6 in Burkharts Add. to the City of Albany, Linn County, Ore., and running thence southerly along the east line of said Bl. a dis. of 637 ft. thence easterly a dis. of 189 ft.

Also, beginning at the southwest corner of Lot 2, Block 6 in supplemental Plat of Burkharts Add. and running thence easterly a distance of 135 feet thence southerly a distance of 400 feet.

No. 2 Beginning at the manhole in the New Pacific Hwy. Main Sewer near the northwest corner of Lot 5, Block 8 in Burkharts Add. to the City of Albany, Linn County, Oregon, and running thence southerly to and through the center of Block 7 and 8 of the supplemental Flat of Burkharts Add. to the City of Albany, Linn County, Oregon, a distance of 900 ft., thence westerly a distance of 60 feet, also easterly a distance of 60 feet.

No. 3 Beginning at the manhole in the New Pacific Hwy. Main Sewer near the northwest corner of Lot 1, Block 8, in Burkharts Add. to the City of Albany, Linn County, Oregon, and running thence southerly to the Northwest corner of Lot 6, Block 11, of the Supplemental Flat to Burkharts Add. a dis. of 200 feet.

GEARY STREET LATERALS:

No. 1 Beginning at the manhole in the Geary Street Main Sewer between Willamette and Front Streets and running thence easterly through the center of Blocks 6 and 5 in Woodles Riverside Add. to the City of Albany, Linn County, Oregon, a distance of 907 feet and Block 4 and 9, Burkhart Park Add.

No. 2 Beginning at the manhole in the Geary Street Main Sewer between Front and Water Streets and running thence easterly through the center of Blocks 7 and 8 in Woodles Riverside Add. to the City of Albany, Linn County, Oregon, and Blocks 3 and 10 in Burkhart Park Add. a distance of 917 feet.

No. 3 Beginning at the manhole in the Geary Street Main Sewer between Water and First Streets and running thence through the center of Blocks 10 and 9 in Woodles Riverside Add. to the City of Albany, Linn County, Oregon, and Blocks 2 and 11, in Burkharts Park Add. to the City of Albany, Linn County, Oregon a distance of 928 feet.

No. 4 Beginning at the manhole in the Geary St. Main Sewer between First and Second Sts. and running thence through the center of Bls. 11 and 12 in Woodles Riverside Add. to the City of Albany, Linn County, Oregon, and Bls. 1, 12, and 13 in Burkhart Park Add. to the City of Albany, Linn County, Oregon a distance of 1034 feet.

No. 5 Beginning at the manhole in the Geary St. Main Sewer between Second Street and the Salem Road and running thence through the center of Blocks 14 and 13 in Woodles Riverside Add. to the City of Albany, Linn County, Oregon, a distance of 374 feet.

FIFTH STREET LATERALS:

No. 1 Beginning at the manhole in the Fifth Street Main Sewer between Geary and State Streets, and running thence northerly through the center of Blocks 9 and 10 in Bryants Add. to the City of Albany, Linn County, Oregon, a distance of 400 feet.

Also, beginning at the same point and running thence southerly through Blocks 8 and 7 in said Add. a distance of 404 feet.

No. 2 Beginning at the manhole at the east end of the Fifth Street Main Sewer and running thence southerly through the center of Blocks 2 and 2 in Bryants Park Add. to the City of Albany, Linn County, Oregon, a distance of 485 feet.

Also, beginning at a point in said lateral in the center of Block 2 in said Add. and running thence easterly a distance of 60 feet.

Also, beginning at a point in said lateral in the center of Block 3 in said Add. and running thence easterly a distance of 60 feet.

Also, beginning at the manhole at the east end of the Fifth Street Main Sewer and running thence northerly along the east line of Lots 9 to 1 inclusive, Block 1 in Bryants Add. to the City of Albany, Linn County, Oregon a distance of 546 feet.

Also, beginning at the northeast corner of Lot 8 in said Block and running easterly through the center of Block 5 in R. L. Burkharts Add. to the City of Albany, Linn County, Oregon, a distance of 380 feet.

EIGHTH STREET LATERALS:

No. 1 Beginning at the manhole in the Eighth Street Main Sewer near the center line of Lot 6 in St. James Park Add. to the City of Albany, Linn County, Oregon, and running thence southerly through Lots 6, 7, 8 and 9 in said Add., a distance of 460 feet.

No. 2 Beginning at the manhole in the Eighth Street Main Sewer near the center line of Lot 4 in St. James Park Add. to the City of Albany, Linn County Oregon, and running thence southerly through lots 4, 3, 2 and 1 in said Addition, a distance of 460 feet.

MONTGOMERY STREET LATERALS:

No. 1 Beginning in the Montgomery St. Main Sewer on the north line of Block 1, in Bacon Add. to the City of Albany, Linn County, Oregon and running thence westerly along the north line of said Block a distance of 340 feet. and running thence southerly a distance of 60 feet.

Also, beginning at the same point and running thence easterly a distance of 510 feet, and thence southerly a distance of 60 feet.

No. 2 Beginning at the manhole in the Montgomery St. main sewer on the center line of Block 2 in Bacon Add. to the City of Albany, Linn County, Oregon and running thence westerly a distance of 190 feet, thence north-easterly a distance of 60 feet.

Also, a sub-lateral beginning at the northwest corner of Lot 32 in said Block and running thence southerly a distance of 60 feet.

Also, beg. at the manhole in the Montgomery St. Main Sewer as above and running thence easterly along the center line of said Bl. a distance of 590 ft. to a manhole in Marion St., thence southerly through Bls. 1 and 2 in Hackleman's Sunrise Add. to the City of Albany, Linn County, Oregon a distance of 760 ft. to a manhole on A. Street.

Also a sub-lateral beginning at the northeast corner of Lot 5 in Block 2 in Hackleman's Sunrise Add. to the City of Albany, Linn County, Oregon and running westerly a distance of 63 feet.

Also, beginning at the southwest corner of Lot 17 Block 2 in said Bacon Add. and running northerly a distance of 60 feet.

Also, beginning at the southwest corner of Lot 17, Block 2, in said Add. and running southerly a distance of 60 feet.

No. 3 Beginning at the manhole in the Montgomery Street Main Sewer on the south line of Bacon Add. to the City of Albany, Linn County, Oregon, and running thence easterly along the south line of said Add. a distance of 362 feet; thence northerly a distance of 25 feet.

Also, beginning at said manhole and running thence southwesterly a distance of 210 feet thence northwesterly a distance of 900 feet, and southeasterly a distance of 250 feet.

Also, a sub-lateral beginning near the southwest corner of Lot 7, Bl. 3 in Bacon Add. to the City of Albany, Linn County, Oregon, and running thence southerly a distance of 330 feet.

LITERAL IN BLOCK 40 CITY OF ALBANY:

No. 1 Beginning at the manhole on the Cottage Street Main Sewer near the west boundary of Block 40 in the City of Albany, Linn County, Oregon and running thence easterly along the center line of said Block a distance of 500 feet, except 4d ft. of lateral already in place leaving 452 feet.

LITERAL IN BLOCK 8 & 9, CITY VIEW ADD:

No. 1 Beginning at the west end of the present Lateral 1 in Block 9, City View Add. to the City of Albany, Linn County, Oregon, and running thence westerly along the center line of Blocks 9 and 8 in said Add. a distance of 462 feet.

LITERAL BETWEEN 8th & 9th STREETS, SWENSON & DRIVER

No. 1 Beginning at the manhole in the south end of the Oak Street Main Sewer between 6th and 9th Streets in the City of Albany, Linn County, Oregon and running thence Easterly a distance of 600 feet.

WHEREAS, the Council on the 27th day of March, 1946 by Resolution No. 83 duly adopted, determined and resolved that they deemed it expedient and said Council proposed to construct the lateral sewers hereinabove described; and

WHEREAS, the Recorder, pursuant to said Resolution No. 83, gave due notice of said proposed improvement in the manner provided by the Charter of said City and on the 7th day of May, 1946, pursuant to said notice, Leonard & Slatte Ore. Ltd. submitted their bid to the Council for the making of said improvement for the sum of \$ 84,520.05 which said bid was received and accepted by the Council in and by Ordinance No. 1701 passed by the Council on the 8th day of May, 1946 and approved by the Mayor on the 8th day of May, 1946; and

WHEREAS, the Council thereupon entered into a contract with the said Leonard & Slate Ore. Ltd. who thereupon proceeded to and did construct said sewers under and pursuant to said contract and thereafter said work was accepted by the Council of the City of Albany, Oregon.

THEREFORE THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That the cost of constructing the following lateral sewers in the City of Albany, Oregon, to-wit:

HACKLEMAN STREET LATERALS:

No. 1 Beginning at the manhole in the Hackleman Street Main Sewer and running thence northerly through the center of Bls. 6 and 7 in "Winona Park Add. to the City of Albany, Linn County, Oregon, a distance of 470 feet.

No. 2 Beginning at the manhole in the Hackleman Street Main Sewer, and running thence northerly through the center of Blocks 5 and 8 in "Winona Park Add. to the City of Albany, Linn County, Oregon, a distance of 680 feet.

No. 3 Beginning at the manhole in the Hackleman Street Main sewer, and running thence northerly through Blocks 4 and 9 in "Winona Park Addition to the City of Albany, Linn County, Oregon, a distance of 548 feet.

No. 4 Beginning at the manhole in the Hackleman Street Main Sewer, and running thence northerly through the center of Block 3 in "Winona Park Add. to the City of Albany, Linn County, Ore., a distance of 366 feet.

No. 5 Beginning at the manhole in the Hackleman Street Main Sewer and running thence northerly through the center of Block 2 in Winona Park Add. to the City of Albany, Linn County, Oregon, a distance of 324 feet.

No. 6 Beginning at the manhole in the Hackleman Street Main Sewer, and running thence northerly through the center of Block 1 in "Winona Park Addition to the City of Albany, Linn County, Oregon, a distance of 160 ft.

No. 7 Beginning at the manhole in the Hackleman St. Main Sewer and running thence southerly through the center of Blocks 5, 4, and 3 in Hack's Sunrise Add. to the City of Albany, Linn County, Oregon, a distance of 1203 feet.

No. 8 Beginning at the manhole in the Hackleman Street Main Sewer and running thence southerly along the east line of Blocks 6, 7, 8 and 9 in Hack's Sunrise Add. to the City of Albany, Linn County, Oregon a distance of 1180 feet, together with sub-laterals connected therewith and running easterly as follows.

- (a) Through Block 1 of the Epauline Add. a distance of 130 feet.
- (b) Through Blocks 6, 5, & 4, of the Epauline Add. a distance of 607 feet.
- (c) Through Blocks 7, 8, & 9 of the Epauline Add. a distance of 607 feet.
- (d) Through Blocks 12, 11, & 10, of the Epauline Add. a distance of 607 ft.
- (e) Through Blocks 13, 14, & 15, of the Epauline Add. a distance of 607 ft.

Making a total distance of 4104 linear feet.

Also beginning at the manhole on the Hackleman Street Main Sewer Midway between Tremont and Wood Streets and running thence southerly through Block 2 in the Epauline Add. to the City of Albany, Linn County, Oregon, a distance of 180 feet.

Also beginning at the manhole on the Hackleman Street Main Sewer a distance of 53.75 feet west of the west line of Lafayette Street and running southerly through Block 2 in the Epauline Add. to the City of Albany, Linn County, Oregon, a distance of 180 feet.

No. 9 Beginning at the manhole in the Hill Street Main Sewer and running thence easterly through the center of Block 1 in Price's Add. to the City of Albany, Linn County, Oregon, a distance of 381 feet.

No. 10 Beginning at the manhole in the Hill Street Main Sewer 38.2 feet south of the south line of 10th St. in Price's Add. to the City of Albany, Linn County, Oregon and running thence easterly a distance of 757 feet, together with sub-laterals connected therewith and running southerly in Hackleman's Grove Add. to the City of Albany, Linn County, Oregon, as follows:

- (a) Through the center of Bl. 1 of said Add. a distance of 264 feet.
- (b) Through the center of Bls 2 & 3 of said Add. a distance of 250 ft.
- (c) From the east end of the lateral sewer above described thence southerly a distance of 188 ft.

No. 11 Beginning at the manhole in the Hackleman Street Main Sewer and running thence northerly along the center line of a 30 foot street through Block 1, in Oak Grove Acres, to the City of Albany, Linn County, Oregon, a distance of 214 feet.

Also, beginning at the manhole in the Hacklerian Street Main Sewer and running thence northerly along the west line of Lots 3, 2, and 1, in Oak Grove Acres, to the City of Albany, Linn County, Oregon, a distance of 214 feet.

No. 12 Beginning at the manhole at the south end of Main Sewer on Sherman Street in Oak Grove Acres and running thence west along the south line of Lots 1, 2, and 3 in Block 2 in said Oak Grove Acres, to the City of Albany, Linn County, Oregon, a distance of 206 feet.

Also, beginning at the northwest corner of Lot 34 in said Block 2, thence southerly through the center of said Bl. 2 a distance of 1050 feet, to the north line of lot 19 in said Bl. and running thence easterly 48 feet and also westerly 50 feet.

No. 13 Beginning at the manhole at the south end of Main Sewer on Sherman Street in Oak Grove Acres and running thence southerly along Sherman St. a distance of 450 feet., thence easterly along the south line of Lot 17 in Bl. 3 in said Oak Grove Acres, to the City of Albany, Linn County, Oregon, a distance of 90 feet, thence southerly through said Bl. 3 a distance of 725 feet, also beginning at the northeast corner of Lot 4 in said Bl. and running westerly along the sout. line of lot 2 in said Bl. a distance of 90 feet.

COLUMBUS STREET LATERALS

No. 1 Beginning at the manhole on Columbus St. Main Sewer between Williamette and Front Sts. and running thence westerly through the center of Bl. 16 in Burkhart Park Add., to the City of Albany, Linn County, Oregon, a distance of 382 feet.

Also, beginning at the same point and running easterly through the center of Bls. 21 and 25 in Burkhart Park Add. to the City of Albany, Linn County, Oregon, a distance of 1214 feet.

No. 2 Beginning at the manhole on Columbus St. Main Sewer Between Front and Water Streets and running westerly through the center of Bl. 15 Burkhart Park Add. to the City of Albany, Linn County, Oregon, a distance of 382 feet.

Also, beginning at the same point and running easterly through the center of Blocks 22 and 24 in Bryants Park Add. to the City of Albany, Linn County Oregon, a distance of 949 feet.

No. 3 Beginning at the manhole on Columbus St. Main Sewer between Water and First St. and running westerly through the center of Block 14, Burkhart Park Add. to the City of Albany, Linn County, Oregon, a distance of 382 feet.

Also, beginning at the same point and running easterly through the center of Bl. 23, Burkhart Park Add. to the City of Albany, Linn County, Oregon, a distance of 219 feet.

OLD PACIFIC HIGHWAY LATERALS:

No. 1 Beginning at the manhole in the Old Pacific Hwy. sewer near the northwest corner of Block 1 in Lotley Add. to the City of Albany, Linn County, Oregon and running thence southerly along the west line of said Block and the east line of Block 4 in Burkharts add. to the City of Albany, Linn County, Oregon a distance of 1096 feet.

Also, beginning at the southeast corner of Lot 16, Block 4, of said add. and running thence easterly a distance of 200 feet.

No. 2 Beginning at the manhole in the Old Pacific Hwy. Main Sewer near the Northwest corner of Lot 7 in bl. 1, R. L. Burkharts Add. to the City of Albany, Linn County, Oregon, and running thence southerly through said Bl. 1 in said Add. to the south line thereof a distance of 450 feet.

Also, beginning at the southwest corner of Lot 7 in said Bl. 1 and running Westerly a distance of 120 feet.

No. 3 Beginning at the manhole in the Old Pacific Hwy. Main Sewer near the Northeast corner of Lot 3, Bl. 1, in Burkharts Add. to the City of Albany, Linn County, Oregon, and running thence southerly a distance of 165 feet.

NEW PACIFIC HIGHWAY LATERALS:

No. 1 Beginning at the manhole in the new Pacific Hwy. Main Sewer near the northeast corner of Lot 1, Bl 6 in Burkharts Add. to the City of Albany, Linn County, Oregon, and running thence southerly along the east line of said Bl. a distance of 637 feet, thence easterly a distance of 189 feet.

Also, beginning at the southwest corner of Lot 2, Bl. 6 in Supplemental Plat of Burkharts Add. and running thence easterly a distance of 135 feet thence southerly a distance of 400 feet.

No. 2 Beginning at the manhole in the New Pacific Hwy. Main Sewer near the northwest corner of Lot 5, Block 8 in Burkharts Add. to the City of Albany, Linn County, Oregon, and running thence southerly to and through the center of Blocks 7 and 8 of the Supplemental plat of Burkharts Add. to the City of Albany, Linn County, Oregon, a distance of 900 feet, thence westerly a distance of 60 feet, also easterly a distance of 60 feet.

No. 3 Beginning at the manhole in the New Pacific Hwy.
