A BILL FOR:

AN ORDINANCE to amend Sub-division "B" of Section 16 of Ordinance No. 1735 of the City of Albany, Oregon, entitled "AN ORDINANCE DIVIDING THE CITY OF ALBANY INTO DISTRICTS: PRESCRIPTION THE USES TO WHICH THE PROPLETY IN SUCH DISTRICTS IN BE PUT: PROULATING, RESTRICTING AND PROHIBITING THE LOCATION OF INDUSTRIES, TRADEC, APARTMENT HOUSES, TWO FAMILY HOUSES AND SINGLE FAMILY HOUSES, REGULATING AND RESTRICTING THE AREA AND DIMENSIONS OF LOTS AND VARDS: THE EXCEPTION, ALIGNMENT OF BUILDINGS, AND THE HIGHMAND ALIGNMENT THEREOF, PROVIDING FOR THE ESTABLISH BUT OF BUILDING SET BACK LIMES: PROVIDING FUNALTIES FOR THE VIOLATION THEREOF, AND REFEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN COMPLICE THEREOF, " passed by the Council September 11, 1946, and approved by the Mayor September 11, 1946.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

That sub-division "B" of Section 16 of Ordinance No. 1735 of the City of Albany, Oregon entitled "AU CEDETATCH DIVIDING THE CITY OF ALBANY INTO DIVIDICES; PRESCRIBING THE USES TO WHICH THE PRIVATE HIS SUCH DISTRICTS HAVE BUT THE RESTRICTING AND FROMIBITING THE LOCATION OF THUSTRIES, TRADES, ARAPT BUT LOUGES, TWO FAMILY FOUSES AND SHIGHL FAMILY HOUSES, PROVIDING THE AREA AND DIMENSIONS OF LOPE WE WARDS: "TO EFFECTION, ALTERATION AND HARMITHAM OF BUILDINGS, AND THE HEIGHT AND ALIGHENT TWIRLOF, PROVIDING FOR THE ESTABLISH OF OF BUILDING SET BACK LINES: PROVIDING PRABILITS FOR THE VICLATION TILPEOF, AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFILIED THEREWITH," passed by the Council September 11, 1946, and approved by the Mayor September 11, 1946, be and the same is hereby amended to read as follows:

B. Commercial Zone.

1. In the commercial zone no building or premises shall be used and no building shall be hereafter erected or structurally altered unless otherwise provided in this ordinance except for one or more of the following uses:

Any use permitted in the residential zone.
Boarding houses and loding houses
Churches
Educational and charitable institutions
Hospital and samitariums, except those for the insone
and similar special use.
Hotels, motor courts
Private clubs, lodges and frate mities
Public garages, service stations
Recreational interprises
Retail stores and shops including service establishments
Schools
Tholesale establishments and warehouses
Outdoor advertising structures
