

ORDINANCE NO. 1766

A Bill For:

AN ORDINANCE providing for the time and manner of vacating a certain unnamed street lying directly South of Pipe's South Albany Addition and directly North of the West half of the John Millard Land Plat (lot 6) and connecting B Street with Pacific Highway; said street being 40 feet in width and approximately 110 feet in length, and declaring an emergency.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That the Mayor and Council of the City of Albany, Oregon are hereby authorized and directed to proceed to vacate that certain unnamed street lying directly South of Pipe's South Albany Addition and directly North of the John Millard Land Plat (lot 6) and connecting B Street with the Pacific Highway, in Albany, Linn County, Oregon.

Section 2. The Recorder of the City of Albany, Oregon, is hereby authorized and directed to give notice of vacation of said street hereinabove described by publishing the same in the Albany Democrat Herald, a newspaper of general circulation published in the City of Albany, Oregon, once each week for four successive weeks, which said notice shall describe said street herein contemplated to be vacated and which said notice shall state that the Council of the City of Albany, Oregon will on the 9th day of April, 1947, at 7:30 P.M. of said day, at the City Council Chambers of the City of Albany, Oregon, hear objections or remonstrances to the vacation of said alley by any person or persons interested therein and particularly by the owners of the real property affected thereby. The Recorder of said City, within five days after the first publication of said notice, shall post or cause to be posted at or near each end of said street herein proposed to be vacated a copy of said notice which shall be headed "NOTICE OF STREET VACATION", such notice shall also be posted in at least two conspicuous places within said proposed vacation of said street. The posting and the first day of such notice shall not be less than twenty-eight days before the time of such hearing as hereinabove stated.

Section 3. Whereas, the peace, health and safety of the people of the City of Albany requires that this ordinance shall become immediately effective; THEREFORE, an emergency is hereby declared to exist and this ordinance shall become in full force and effect immediately upon its final passage by the Council and approval by the Mayor.
