A BILL FOR:

All ORDINANCE declaring a deficit on account of the improvement of SECOLD STREET from east Pine to Geary St.; HARRISON STREET from Second to First Street; and CILVLAND STREET from Second to Front Streets, in the City of Albany, Linn County, Oregon, by D. F. McKenzie, and directing the Recorder of said City to place to the debit of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed and entered of record in the Docket of City Liens of the City of Albany, Oregon for the making of said improvement, their proportionate share of such deficit.

## THE PEOPLE OF THE CITY OF ALBANY DO CRDAIN AS FOLLOWS:

Section 1. That a deficit of \$1135.59 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into by and between the City of Albany, Oregon and D. F. Lickenzie for the improvement of Second Street from east Pine to Geary 3t.; Harrison Street from Second to First Street; and Cleveland Street from Second to Front Streets, in the City of Albany, Oregon, against the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the making of said improvement.

Section 2.
