A BILL FOR:

AN ORDINANCE declaring a surplus on account of the improvement of TWELFTH STREET from the east line of Elm Street to the west line of Vine Street; THE STREET from the east line of Elm Street to the west line of Vine Street; TOURTHENTY STREET from the east line of Elm Street to the west line of 7ine Street; TALLUT STREET from the south line of Eleventh Street to the north line of Fifteenth Street; MAPLE STREET from the south line of Eleventh Street; to the north line of Fifteenth Street; in the City of Albany, Linn County, Oregon, by D. F. McKenzie and O. L. Bowman, and directing the Recorder of said City to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed and entered of record in the Docket of City Liens of the City of Albany, Oregon for the making of said improvement, their proportionate share of such surplus.

## THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$2003.91 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into, by and between the City of Albany, Oregon, and D. F. Section 2.
