## ORDINANCE NO. 1921

A BILL FOR:

AN ORDINANCE authorizing the Mayor and Recorder of the City of Albany, Oregon, to enter into a contract with Donald L. Keebler and Jack L. Keebler dba Keebler Sand and Gravel Company, for the improvement of Umpqua Street from the west line of Takena Street, or Jottage Street, to the east line of Lawnridge Street, in the City of Albany, Oregon.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

WHEREAS, by Ordinance No. 1908 of the City of Albany, Oregon, it was ordered that the following street in said City be improved, to-wit: Umpqua Street from the west line of Takens Street, or Cottage Street, to the east line of Lawnridge Street,

Said improvement to be made in the following manner:

B/ grading and graveling said strest.

Bylaying and constructing concrete gutters.
 By constructing concrete curbs and sidewalks where necessary.

By installing a proper drainage system.

and in accordance with the plans, specifications and estimates of Harold W. Poling, Engineer, then on file in the office of the Recorder of said City; and

WHEREAS, it was provided in said Ordinance that the Recorder of said City of Albany give notice for bids for the making of sail improvements in the manner provided by law and said Ordinance;

WHEREAS, after due notice and advertisement for ids made and given by whichers, after due notice and advertisement for hids hade and given by
the Recorder according to law and the Ordinance last aforesaid, to-wit: on the
28th day of July, 1945, Ponald L. Keebler and Jack L. Keebler dba Keebler Sand and
Gravel Company presented to the Council of the City of Albany his bid for making
said improvement in the ranner aforesaid, which bid was made in due form and in
conformity with all the conditions imposed by law and the Council by which said bid
Donald L. Keebler and Jack L. Keebler dba Keebler Sand and Gravel Company proposed to
furnish all the material and implements and performs all the labor necessary to make
the above described improvement for the following paged prices, howeit: the above described improvement for the following maned prices, to-wit:

Aggregate bid based on Engineer's estimates \$3,279.00.

AND WHEREAS, the said Donald L. Keebler and Jack L. Keebler dba Keebler Sand and Gravel company cas te lowest bi der for said proposed work and said bid was the lowest and best bid made therefor.

Section 1. That the bid of Donald L. Keebler and Jack L. Keebler dba Keebler Sand and Gravel Company for the improvement of Unpqua Street from the west line of Takena Street, or Cottage Street, to the east line of Lawnridge Street, in the City of Albany, Oregon, in the manner as specified in said Ordinance No. 1908 be and the same is hereby accepted and the Mayor and Recorder of the City of Albany are hereby authorized and directed to enter into a contract in writing with the said Donald L. Keebler and Jack L. Reebler dba Keebler Sand and Gravel Company, for the making of said improvement on behalf of the City of albany upon the terms mentioned in said bid hereinabove mentioned and in the manner and form provided by law.

Said Contract shall provide further that the work on said improvement shall commence within ten days after the signing of said contract and shall be shall commence within ten days after the signing of said contract and shall be prosecuted with such vigor that all the work embraced in said contract shall be entirely completed on or before the leth day of October, 1046, unless further time be extended by the Council of said City, and the City of Ibany, Oregon, shall be deemed to suffer damages in the amount of 125.
