ORDINANCE No. 1934

A BILL FOR:

AN ORDINANCE to determine the probable cost of certain improvement which the Council of the City of Albany, Or gon has determined to make in Resolution "o. 31, adopted by the "ouncil on the 3th day of June 1948, and to make HILL STREET from the South line of Sixth Street to the North line of eighth Street and SIATH STREET from the East line of Hill Street to the West line of Main Street; to ascertain, issess, determine and declare the proportionate share of such probable cost of such improvement of said street that is assessed upon each lot or part thereof adjacent to said part of said Stree to be so im roved; to direct the Recorder of said City to enter a statement of such assessment in the Docket of City Liens as provided by the Charter of said City.

WHEREAS on the 25th day of May, 1348, the Council of the City of Albany, Oregon duly adopted a resolution requiring the City Angine r of said City to make plans, and specifications for the improvement of HILL SIRGLE from the South line of Sixth Street to the North line of Eighth Street and SIXTH SIRGLE from the East line of Hill Street to the West line of Main Street in the following manner to-wit:

By grading and gr.veling said streets.
By laying and constructing concrete gutters, there needed.
By constructing concrete carbs and sidewalks, where needed.
By installing a proper drainage system.

and for the estimates of the work to be done on said portion of said Streat and the probable cost thereof and requiring that such plans, specifications, estimates and probable cost be filed in the Recorder's office of said City, said Resolution being endorsed, "Resolution No. 16", and adopted on the 25th day of May, 1948.

WHEREAS the City Engineer of said City of Albany parsuant to said Resolution No. 16 made plans, specifications and estimates as directed by the said resolution for the improvement of said streets in the manner specified in said Resolution No. 16 and filed said plans, specifications and estimates in the Recorder's office of said wity on the 1 th day of June 1945.

WHEREAS the Council on the 9th day of June 1748 by Resolution No. 31 duly adopted by said council, determined and resolved that it deemed it expedient and that said Council proposed to improve HILL SALAT from the South line of Sixth Street to the North line of Eighth Street and SIXFH SIR of from the East line of Hill Street to the dest line of Main Street, in the manner provided in said Resolution "o. 31 and:

whereas, in and by said Resolution to. 31 adopted as aforesaid by the Council the Recorder of said city was only ordered and directed by said Council to give notice of said proposed improvement of said Streets as provided by the Charter of said City and:

WHEREAS, the Recorder in pursuance of said order and direction of the Council of said City of Albany did duly give notice of said proposed improvement of said Streets in the manner provided by the Charter of said City and:

WHEREAS, the Council in and by said Resolution No. 31 ascertained and determined the total probable cost of making said im rovement of said Street to be paid by the owners of the real property adjacent to said portion of said Streets to be improved as specified in said Resolution No. 31 to be the sum of \$6,700.00.

THEREFORE

THE PEOPLE OF THE CITY OF AL .NY DO PRDAIN AS FOLLOWS:

Section 1. That HILL STREET from the South line of Sixth Street to the north line of Lighth Street and SIXTH STREET from the East line of Hill Street to the west line of Main Street, in the City of albany, Oregon, be improved as follows:

 By grading and graveling said streets.
By laying and constructing concrete gutters, where needed. By constructing concrete curos and sidewalks where needed.

By installing a proper drainage system.

all in accordance with said Resolution Fo, 31 and the plans and specifications for said improvement filed by the City angineer with the Recorder of said City of Albany, Oregon on the 10th day of June 1948.

Section 2. That the probable cost of making said improvement of said Streets in the manner heratofore determined by the Council of albany in and by Resolution No. 31 to be paid by the owners of the real property adjacent to said portion of said Streets is hereby declared to be the sum of \$6,700.00.
