## A BILL FOR

AN ORDINANCE DECLARING A SURPLUS AND A DEFICIT ON A CCOUNT OF THE IMPROVEMENT OF LAWNRIDGE AVENUE FROM 80FT. NORTH OF UMPQUA STREET TO FIFTEENTH STREET, AND UMPQUA STREET FROM THE WEST LIME OF TAKENA TO THE EAST LIME OF LAWNRIDGE, IN THE CITY OF ALBANY, LINN COUNTY, OREGON, BY KEEBLER CONSTRUCTION CO., AND DIRECTING THE RECORDER OF SAID CITY TO PLACE TO THE CREDIT OR DEBIT OF THE SEVERAL OWNERS OF THE VARIOUS PARCELS OF REAL ESTATE ADJACENT TO SAID IMPROVEMENT HERETOFORE ASSESSED AND ENTERED ON THE RECORD IN THE DUCKET OF CITY LIENS OF THE CIT! OF ALBANY, OREGON FOR THE MAKING OF SAID IMPROVEMENT, THEIR PROPORTIONATE SHARE OF SUCH SURPLUS OR DEFICIT.

## THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$1,316.97 and a deficit of \$542.56 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into, by and between the City of Albany, Oregon and Keebler Construction Co. for the improvement of Lawnridge avenue from 80 ft. north of Umpqua Street to Fifthenth Street, and Umpqua Street from the west line of Takena to the East line of Lawnridge, in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens for said City, in the surplus column and deficit column thereof, in the sum of \$1,316.97 and \$542.56 respectively, based upon the several amounts heretofore assessed for making such improvement, and eneteed therein to defray the cost of the improvement, of said street, said surplus ani deficit parcels of real estate, and in the sums as follows, to-wit:
