

## BILL FOR AN ORDINANCE

ORDINANCE NO. 1964

## A. BILL FOR:

AN ORDINANCE DECLARING A SURPLUS AND DEFICIT ON ACCOUNT OF THE IMPROVEMENT OF EIGHTH STREET FROM CLAY TO COLUMBUS; NINTH STREET FROM CLAY TO COLUMBUS AND CLAY STREET FROM EIGHT TO SANTIAN, IN THE CITY OF ALBANY IN LINN COUNTY, OREGON, BY KEEBLER CONSTRUCTION CO., AND DIRECTING THE RECORDER OF SAID CITY TO PLACE TO THE CREDIT OR DEBIT OF THE SEVERAL OWNERS OF THE VARIOUS PARCELS OF REAL ESTATE ADJACENT TO SAID IMPROVEMENT HEREIN BEFORE ASSESSED AND ENTERED ON THE RECORD IN THE DOCKET OF CITY LIENS OF THE CITY OF ALBANY, OREGON, FOR THE MAKING OF SAID IMPROVEMENT, THEIR PROPORTIONATE SHARE OF SUCH SURPLUSES OR DEFICITS.

THE RECORDER OF THE CITY OF ALBANY DO ORDER AS FOLLOWS:

Section 1. That a surplus of \$1,019.03 and a deficit of \$487.03 is hereby ascertained and declared to exist upon the completion of the improvement heretofore entered into, by and between the City of Albany, Oregon and Keebler Construction Co. for the improvement of Eighth Street from Clay to Columbus; Ninth Street from Clay to Columbus and Clay Street from Eighth to Santian, in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens for said City, in the surplus column and deficit column thereof, in the sum of \$1,019.03 and \$487.03 respectively, based upon the several amounts heretofore assessed for making such improvement, and entered therein to defray the cost of the improvement, of said street, said surplus and deficit parcels of real estate, and in the sums as follows to-wit:
