ORDINANCE NO. 1992

AN ORDINANCE providing for the time and manner of improvement of Montgomery Street between south line of 2nd and north line of 3d streets in the City of Albany, Oregon, providing how the cost of such improvement shall be paid, the pensity or damage to the City of albany by the person or persons making such improvement if the same shall not be completed on the time agreed upon, and the giving of a good and sufficient bond for the faithful performance of the work of such improvement, and providing for the giving by the Recorder of said City of hotice for bids for the completion of said improvement, and declaring an emergency.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That MONTGOMERY STREET between south line of 2nd and north line of 3d streets in the City of Albany be improved in the following manner, to-wit:

By grading said street to the proper sub-grade.

By paving with suitable hard surfacing. By laying and constructing concrete gutters where necessary. By constructing concrete curbs where necessary.

By installing a proper drainage system.

Said improvement shall be made in accordance with the Charter and Ordinances of the City of Albany, Oregon, and the plans, specifications and estimates of Barold Poling, Engineer, for the improvement of said street filed in the office of the Recorder of said City of Albany on the 23d day of March, 1949.

The cost of making of said improvement shall be paid out of the funds to be collected and arising upon and out of the assessments hereafter to be made, ascertained andeclared by the Council of the City of Albany on the lots and parts of lots adjacent to said portion of said street so to be improved as hereinabove described and especially and particularly benefited thereby, as provided by the Charter of said City of "Ibany.

Said improvement shall be completed by the 15th day of September, 1949.

All bids for the making of said improvement deemed unreasonable by the Council may be rejected.

Any person, firm or corporation with whom any contract may be entered into by the City of Albany for the making of said improvement shall, before commencing said improvement and at the time of signing such contract, make, execute and deliver to sai City a good and sufficient bond with sufficient surery thereon to be approved by the Nayor of the City of Albany in a sum equal to fifty per cent of the amount to be paid under such contract for the faithful performance thereof.

Section 2. If the person, firm or corporation entering into any contract with the City of Albany to make said improvement shall not complete the same within the time mentioned and specified in such contract, the City of Albany shall be deemed to suffer damages on account thereof in the amount of 325.00 per day for each and every day the completion of said work is delayed beyond the time stated in such contract, which amount shall be paid by such contractor doing the work at the completion thereof unless the time of the completion of said improvement be extended by the Council.

Section 3. The Recorder of the City of Albany is hereby ordered and directed to immediately give proper notice for bids for making of said improvement by publishing such notice ten days in the Albany Democrat-Merald, a newspaper of general circulati n published in the City of Albany, fully describing in each make the time and manner of doing said work of improving said portion of said street.

Section 4. Inasmuch as the provisions of this ordinance are necessary for the immediate preservation of the peace, health and safety of the citizens of the City of Albany, Diezon, an emergency is hereby declared to exist and this ordinance shall be in full force and of lect immediately upon its passage by the Council and its approval by the Mayor of the City of Albany.
