ORDINANCE NO. 2009

ORDINANCE TO AMEND ORDINANCE NO. 1422 ENTITLED "AN ORDINANCE REGULATING TRAFFIC ON THE STREETS AND PUBLIC WAYS OF THE CITY OF ALBANY, ORIGIN; PROVIDING FOR TRAFFIC SIGNS, MARKERS AND SIGNALS; PROVIDING PENALTIES FOR VIOLATIONS HEREOF; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH AND DECLARING AN EMERGENCY ".

The people of the City of Albany do ordain as follows:

That Section 25 shall be amended to read as follows:

Section 25. ONE WAY STREETS, ALLEYS AND DESIGNATION AND RULES REVERSE TURNS OR "U" TURNS PROHIBITED.

- (a) All vehicles leaving a street and turning an alley, private driveway, etc., or leaving an alley and turning into a street, must be turned to the right, and it shall be unlawful for any person to reverse the direction of any motor vehicle upon any street in this city except at street intersections; provided, however, that no reverse or "U" turn shall be made by the driver of any vehicle at any street intersection where any type of sign or marker is erected prohibiting any such reverse or "U" turn.
- The council is hereby authorized to designate that traffic in any alley within the City of Albany shall travel in one direction only and when so designated shall direct that signs or proper markers shall be placed at the entrances to such alleys plainly designating the direction that traffic shall move therein, and when such signs or markers shall be posted, it shall be unlawful for any person to operate any motor vehicle in such alley except in the direction indicated by such signs or markers.

Alleys designated as one-way:

Alley between Water and First Avenues from Broadalbin to Washington - west bound only; Alley between First and Second Avenues from Lyon to Washington Streets - west bound only; alley between Second and Third Avenues from Lyon to Washington Streets - west bound only; alley between water and First Avenues from Broadalbin to Ellsworth-

(c) That the council does hereby designate that traffic on the following described streets within the City of Albany shall travel in one direction only and that it shall be unlawful for any person to operate any motor vehicle along said street except in that direction set out herein and that the entrances to such streets shall be posted by signs or markers that shall indicate the designated direction that traffic shall travel:

Traffic shall travel northerly on the east side of Fllsworth Street north of First Avenue and to where Ellsworth Street intersects the alley between First Avenue and Water Avenue; traffic shall travel in an easterly direction on the south side of Eighth Street between Washington and Lyon Streets; that traffic shall travel in a westerly direction on the north side of Eighth Evenue from Lyon Street to Washington Street.
