ORDINANCE NO. 2/3/

AN ORDINANCE DECLARING A SURPLUS ON ACCOUNT OF THE IMPROVEMENT OF ERMINE STREET FROM THE SOUTH LINE OF 99E TO THE NORTH LINE OF SANTIAM ROAD IN THE CITY OF ALBANY, OREJON BY DONALD L. KEEBLER AND JACK L. KEEBLER d/b/s KEEBLER SAND AND GRAVEL COMPANY, AND DIRECTING THE RECORDER OF SAID CITY TO PLACE TO THE CREDIT OF THE SEVERAL OWNERS OF THE VARIOUS PARCELS OF REAL ESTATE ADJACENT TO SAID IMPROVEMENT HERETOFORE ASSESSED AND ENTERED ON THE RECORD IN THE DOCKET OF CITY LIENS OF THE CITY OF ALBANY, OREGON FOR THE MAKING OF SAID IMPROVEMENT, THEIR PROPORTIONATE SHARE OF SUCH SURPLUS.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$1,204.34 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into, by and between the City of Albany, Oregon and Donald L Keebler and Jack L. Keebler d/b/a Keebler Sand and Gravel Company for the improvement of Ermine Street from the south line of 99E to the north line of Santiam Road in the city of Albany, Oregon and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens for said City in the surplus column thereof in the sum of 31,204.34, based upon the several amounts heretofore assessed for making such improvement, and entered therein to defray the cost of the improvement of said street, said surplus and deficit parcels of real estate, and in the sums as follows, to-wit:
