

ORDINANCE NO. 2550

AN ORDINANCE AMENDING ORDINANCES NUMBERS 2532, 2533, 2534, and 2535 PERTAINING TO THE EFFECTIVE DATE OF THE SAID ORDINANCES ESTABLISHING ONE-WAY TRAFFIC, AND DECLARING AN EMERGENCY.

WHEREAS, on August 11, 1954, the Council of the City of Albany duly passed Ordinances Nos. 2532, 2533, 2534, and 2535, for the purpose of establishing One-Way Streets within the City of Albany and,

WHEREAS, each of the above named ordinances provided that the effective date thereof would be the 15th day of October, 1954, at the hour of 1:00 o'clock A. M., and,

WHEREAS, to properly enforce the ordinances the city and the State of Oregon thru the State Highway Commission were required to erect the proper signs, and,

WHEREAS, the said signs are not now available and it will be impossible to install the said signs on the effective date of the ordinance.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: That Section 2 of Ordinance No. 2532 be and the same is hereby amended to read as follows:

"Section 2: This ordinance upon passage by the Council and approval by the Mayor shall become effective on the 30th day of November, 1954, at the hour of one o'clock A.M."

Section 2: That Section 2 of Ordinance No. 2533 be and the same is hereby amended to read as follows:

"Section 2: This ordinance upon passage by the Council and approval by the Mayor shall become effective on the 30th day of November, 1954, at the hour of 1:00 o'clock A.M."

Section 3: That Section <sup>1</sup> of Ordinance No. 2534 be and the same is hereby amended to read as follows:

"Section 1: That all loading zones heretofore established under or by virtue of Ordinance No. 1681 and any amendments thereto or resolutions thereunder or by any other ordinance or resolution be and they hereby revoked and disestablished as of the 30th day of November, 1954, at the hour of 1:00 O'clock A.M."

Section 4: That Section 2 of Ordinance No. 2535 be and the same is hereby amended to read as follows:

"Section 2: This ordinance upon passage by the Council and approval by the Mayor shall become effective on the 30th day of November, 1954, at the hour of 1:00 o'clock A.M."

Section 5: Inasmuch as the passage of this ordinance is necessary to the immediate preservation of the peace, health, and safety of the citizens of the City of Albany, Oregon in that proper signing of One-Way Streets program cannot be established the effective date in the ordinances previous to amendment an emergency is hereby declared to exist, and this ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor of the City of Albany, Oregon.
