

ORDINANCE NO. 2791

AN ORDINANCE AMENDING ORDINANCE NO. 2762 BY SEGREGATING THE LIEN OF EDITH A. EDHOLM THEREIN ESTABLISHED.

WHEREAS, Edith A. Edholm was assessed for a sanitary sewer in Ordinance No. 2762, under the following described property:

Beginning S. 88°30' W. 825.54' & S. 1°30' E. 306.4' from the N. E. corner of Smead Cl. #53 T. 11 S., R. 3 W., thence S. 1°30' E. 225'; thence N. 88°30' E. 200'; thence N. 1°30' W. 225'; thence S. 88°30' W. 200' to beginning also S $\frac{1}{2}$  of vac. "B" St. adj. on North; also N $\frac{1}{2}$  of vac. "C" st. adj. on South; also vac. 10' strip on East side of Jackson St.
