

Ordinance No. 2848

AN ORDINANCE ANNEXING CERTAIN PROPERTY LYING EAST OF 2ND ADDITION TO VISTA HOMES, LINN COUNTY, OREGON, A PORTION OF BLOCK 3, KURRE LAKESIDE TRACTS, AND A PORTION ADJACENT THERETO.

WHEREAS, on the 27th day of May, 1959, at a regular Council Meeting, the Council of the City of Albany, Oregon, did duly pass Ordinance No. 2843 wherein it was provided that Public Hearing would be held on the 10th day of June, 1959, concerning the advisability of annexing certain property lying East of 2nd Addition to Vista Homes, Linn County, Oregon, a portion of Block 3, Kurre Lakeside Tracts, and a portion adjacent thereto, and

WHEREAS, the hearing was duly held on the 10th day of June, 1959, and at that time, the Council determined that the Notices of hearing had been given as provided in the said Ordinance, and pursuant to the terms of 222.120 ORS, and

WHEREAS, the Council after the said hearing determined that the said certain property lying East of 2nd Addition to Vista Homes, Linn County, Oregon, a portion of Block 3, Kurre Lakeside Tracts, and a portion adjacent thereto be annexed to the City of Albany, and the consent of the property owners have been filed giving their consent for the annexation.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: That the following described property be and it is hereby annexed to the City of Albany, to-wit:

Beginning at the S.E. corner of Tract 32 of 2nd Addition to Vista Homes in Linn County, Oregon, thence N. $0^{\circ}56'$ W. 772.63' to the N.E. corner of Tract 25 of 2nd Addition to Vista Homes, thence S. $86^{\circ}38'$ E. 820' more or less to the W. line of a public road known as Ermine Street, thence Southerly 722' along the W. line of Ermine Street, thence Easterly along the N. line of 34th Ave. 837.42' to the place of beginning, and

All of Block 3, Kurre Lakeside Tracts in the County of Linn, State of Oregon except Lot 9, thereof. ALSO beginning at the S.E. corner of Block 3, Kurre Lakeside Tracts, Linn County, Oregon; thence S. $1^{\circ}25'$ E. 193.63 feet; thence on a 5670 radius curve to the right (the chord of which bears S. $56^{\circ}31'$ W. 165.20'); thence N. $1^{\circ}26'$ W. 281.06'; thence N. $88^{\circ}28'$ E. 140' to the place of beginning.

Section 2: Whereas, it is in the betterment of the public health, interest, safety and general welfare of the citizens of the City of Albany that this matter of annexation of the property described herein be disposed of at the earliest possible moment, and, should the same be annexed, that the City facilities be made available to this property, therefore an emergency is hereby declared to exist and this Ordinance shall become immediately effective upon its passage by the Council and approval by the Mayor.
