

ORDINANCE NO. 2855

AN ORDINANCE TO DETERMINE THE ASSESSMENTS AGAINST THE PROPERTY SPECIFICALLY BENEFITED BY CERTAIN SEWER IMPROVEMENTS, AND DECLARING AN EMERGENCY.

Recitals

1. The sewer assessments as referred to in this Ordinance and previous Resolutions and Ordinances is "Cox Creek Lateral No. 1".
2. Preliminary Resolutions and Ordinance prescribing the manner and extent of the improvements are set forth in Resolutions 496 and 506 and in Ordinance Numbers 2723 and 2778.
3. The assessments set forth in the following Ordinance are based upon the request and recommendation of the City Engineer in compliance with Ordinance Number 2723 and 2778.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: The total cost of the sewer improvements for the "Cox Creek Lateral No. 1" is hereby determined to be \$3,305.74. The following represents a breakdown of the costs to be assessed against the property particularly benefited thereby:
