TITLE: An Ordinance providing for the date and manner of holding a special election of a portion of Rodgers Acres Addition extending from the present city limits to 34th Avenue, on the 4th day of December, 1959, for the purpose to submit to the legal voters of said territory for their adoption or rejection of a proposal to annex a portion of Rodgers Acres Addition and 1st Addition to Rodgers Acres, to the City of Albany, Oregon, and declaring an emergency.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: TIME AND DATE OF ELECTION

That in a manner provided by law and in this Ordinance, for the purposes set forth herein, a special election shall be held in a portion of Rodgers Acres Addition and 1st Addition to Rodgers Acres to the City of Albany, Linn County, Oregon, as below described, on the 4th day of December, 1959, commencing at the hour of 8 o'clock a.m. on said day, Pacific Standard Time.

Section 2: VOTING PLACE

The following is hereby designated as the voting place of said election:

The Dr. James Clunes residence, 3515 South Sherman Street, Albany, Oregon.

Section 3: JUDGE AND CLERKS

That the judge and the clerks of said special election who shall supervise the election within the below described territory shall be:

Section 4: NOTICE

The City Recorder shall cause notice of said special election to be given by publication thereof in a newspaper of general circulation within the city once a week for four (4) consecutive weeks, the first date of publication to be on the 30th day of October, 1959, and said notice shall state the time, voting place and description of the territory proposed to be annexed.

Section 5: FORM OF NOTICE

The Recorder, in addition to the notice required by Section 4 above, shall cause to be posted in four (4) conspicuous places within the territory proposed to be annexed, at least ten (10) days before the date of election, notices of a special election in the following form:

ASPECIAL ELECTION NOTICE

NOTICE IS HEREBY GIVEN that on the 4th day of December, 1959, at the Dr. James Clunes residence, 3515 South Sherman Street, Albany, Oregon, a special election will be held concerning the proposed annexation of the following described territory in the City of Albany:

Beginning at the Northeast corner of Rodgers
Acres Addition;
thence Westerly along the North boundary of
Rodgers Acres Addition to the present city
limits;
thence Southerly along said city limits to the
North line of 34th Avenue;
thence Easterly along the North line of 34th
Avenue to the West line of Geary Street;
thence Northerly along the West line of Geary
Street to the point of beginning.

Which election will be held at 8 o'clock in the morning and will continue until 8 o'clock in the afternoon Facific Standard Time of said day. Registered voters in the said territory are invited to vote upon the proposed annexation.
