TITLE: AN ORDINANCE ELECTING TO DISPENSE WITH AN ELECTION WITHIN THE CITY OF ALBANY PURSUANT TO 222.120 ORS REGARDING THE ANNEXATION OF AREA 5 - A PORTION OF NORTH ALBANY: SETTING A TIME FOR PUBLIC HEARING ON THE SAME AND DECLARING AN EMERGENCY.

RECITALS:

whereas, it has heretofore been determined to hold an election in an area herein described from the purpose of determining whether or not the residents in that area desire to be annexed to the City of Albany,

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: DESCRIPTION OF PROPERTY

That an election within the City of Albany for the purpose of annexing the following described property, to-wit:

Beginning at a point at the intersection of the S. line of Quarry Rd. and the W. line of Spring Hill Rd.; thence Southerly along the W. line of Spring Hill Rd. to a point which is the intersection of the W. line of Ellsworth St. extended Northerly and the N. line of Spring Hill Rd.; thence Southerly along the W. line of Ellsworth St. extended to the city limits line in the center line of the Willamette River; thence Westerly along the center line of said river to a point that is on the E. line of Gibson Hill Rd. extended Southerly; thence Northerly along the E. line of Gibson Hill Rd. extended, to the intersection of the N. line of Walnut Rd. and the E. line of Gibson Hill Rd.; thence Westerly along the N. line of Gibson Hill Rd.; thence Northerly along the E. line of Gibson Hill Rd. to the intersection of the E. line of Gibson Hill Rd. and the S. line of Laurel Heights Drive; thence Easterly along the S. line of Laurel Heights Drive extended Easterly to the S. line of Quarry Rd.; thence Easterly along the S. line of Quarry Rd. to the intersection of the S. line of Quarry Rd. and the W. line of Spring Hill Rd., being the point of beginning,

shall be and is hereby dispensed with pursuant to and under the terms of 222.120 ORS.

Section 2: TIME AND PLACE OF HEARING - NOTICES

That there shall be held a public hearing as to the advisability of annexing a portion of North Albany, described in Section 1, to the City of Albany on the 23rd day of December, 1959, at the hour of 7:15 oldlock p.m. in the City Hall, Albany, Oregon, and the City Recorder of the City of Albany is hereby directed to give notice of the said public hearing by publishing in a newspaper of general circulation in said city once a week for two (2) successive weeks prior to the election and by posting a notice in four (4) public places for the same length of time setting forth the time and place of said hearing and the description of the property to be considered for annexation and the purpose for which the hearing is held.

Section 3: EMERGENCY CLAUSE

Whereas, it is for the betterment of the public health, interest, safety and general welfare of the citizens of the City of Albany that this

matter of unnexation of property described herein be disposed of at the earliest possible moment and an emergency is hereby declared to exist and this ordinance shall become immediately effective upon its passage by the Council and approval by the Mayor.
