

ORDINANCE NO. 2990

AN ORDINANCE AMENDING ORDINANCE NO. 2819 BY SEGREGATING THE LIENS OF JACK & BARBARA DRAPER, FOR LOTS 20, 21, 22, 23 AND 24, FIRST ADDITION TO RODGERS ACRES, THEREIN ESTABLISHED.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:


Section 1: That Ordinance No. 2819 be amended to segregate the liens therein created on the above properties in the following manner:
