

ORDINANCE NO. 3019

AN ORDINANCE ANNEXING 2ND ADDITION TO HAWTHORNE PARK AND LOT 5, BLOCK 3, GLENDORR ADDITION TO THE CITY OF ALBANY, OREGON, AND DECLARING AN EMERGENCY.

WHEREAS, on the 9th day of May, 1962 at a regular council meeting, the Council of the City of Albany, Oregon, did duly pass Ordinance No. 3012, wherein it was provided that a Public Hearing would be held on the 13th day of June, 1962, concerning the advisability of annexing to the City of Albany, Linn County, Oregon, and

WHEREAS, the hearing was duly held on the 13th day of June, 1962, and at that time, the Council determined that the Notices of Hearing had been give as provided in the said Ordinance, and pursuant to the terms of ORS 222.120, and

WHEREAS, the Council after the said hearing determine that 2nd Addition to Hawthorne Park and Lot 5, Block 3, Glendorr Addition to the City of Albany, Linn County, Oregon, be annexed to the City of Albany, and the consent of the property owners having been filed giving their consent to the annexation,

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: That the following described property be and is hereby annexed to the City of Albany, to wit:

Lot 5, Block 3, Glendorr Addition; and beginning S.0°26'W. 677.10 feet from the Southeast corner of Lot 10, Block 2, Liberty Addition to the City of Albany, Linn County, Oregon, said point being 1030.74 feet east and 319.82 feet south of the Southeast corner of the George Cline D.L.C. 84 in T. 11 S., R. 4 W. of the W.M. in Linn County, Oregon, and being also the intersection of the West line of Umatilla Street with the South line of 28th Avenue; and running thence N. 89°34'W. along the South line of 28th Avenue 352.24'; thence S. 75°48' W. along the South line of said 28th Ave. 320.35' to the Easterly line of Tract 66 of Fir Oaks 2nd Addition; thence S. 14°12' E. along the Easterly line of said Fir Oaks 2nd Addition 336.67 feet to a point N. 14°12'W. 52 feet from the angle point in the East line of said Addition; thence S. 89°34' E. 183.14 feet; thence N. 0°26'E. 16.39 feet; thence S. 89°34' E. 343.79 feet; thence N. 0°26'E. 110.0 feet; thence S. 89°34'E. 50.0 feet; thence N. 0°26'E. 60.0 feet; thence S. 89°34' E. 110.0 feet; thence N. 0°26' E. 348.39 feet to the present South line of Albany city limits; thence N. 89°34' W. 110.0 feet to the East line of Umatilla Street; thence S. 0°26' W. 128.23 feet to a point S. 89°34' E. 50.0 feet from the place of beginning; thence N. 89°34' W. 50.0 feet to the place of beginning.

Section 2: That a copy of this ordinance shall be filed in the office of the City Recorder and the number of this ordinance shall be noted on the official zoning map of the City of Albany.

Section 3: Whereas, it is in the betterment of the public health, interest, safety and general welfare of the citizens of the City of Albany that this matter of annexation of the property described herein be disposed of at the earliest possible moment, and should the same be annexed, that the City facilities be made available to this property, therefore an emergency is hereby declared to exist and this Ordinance shall become immediately effective upon its passage by the Council and approval by the Mayor.
