

ORDINANCE NO. 4336

AN ORDINANCE AMENDING ORDINANCE NO. 4260 SEGREGATING THE LIENS OF VIRGINIA A. STRAIT AND JESSIE GRIESER AND DECLARING AN EMERGENCY.

Whereas, Virginia A. Strait and Jessie Grieser were assessed for sewer improvements under Ordinance No. 4260 for SS-78-17, Nelson Mobile Village Sanitary Sewer, as follows:
