

ORDINANCE NO. 5005

AN ORDINANCE AMENDING ALBANY MUNICIPAL CODE 2.08.040, WARDS.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: Albany Municipal Code 2.08.048, Wards, is hereby amended as follows:

2.08.040 Wards. For the purpose of municipal representation, the city is hereby divided into three wards designated and bounded as follows:

Ward I is hereby declared to include all of that property of the city north of the Willamette River; and all of that property of the city west of the following line: Beginning at the north end of Main Street in the city of Albany; hence southerly along the centerline of Main Street to the intersection of the centerlines of Main Street and Salem Avenue; hence easterly along the centerline of Salem Avenue to the center of Periwinkle Creek; hence southerly along the center of Periwinkle Creek to the center of Pacific Boulevard; hence westerly along the centerline of Pacific Boulevard to a point where the railroad track crosses Pacific Boulevard; hence southerly along the Southern Pacific Railroad line to a point approximately 2,000 feet south of 34th Avenue; hence westerly approximately 3,500 feet; hence northerly approximately 1,600 feet; hence ~~westerly approximately 500 feet to the Calapooia River~~, following the city boundary to the intersection of the Calapooia River.

Ward II is hereby declared to include that property that is in the following area: Beginning at the intersection of the center of Pacific Boulevard at a point which would be formed at the centerline of Thurston Street if it was extended to cross Pacific Boulevard; hence southerly along the centerline of Thurston Street to the centerline of Queen Avenue; hence easterly along the centerline of Queen Avenue to the centerline of Geary Street; hence southerly along the centerline of Geary Street to the center of the Santiam Canal; hence easterly along the center of the Santiam Canal to the centerline of Columbus Street; hence southerly along the centerline of Columbus Street to the Southern Pacific Railroad tracks; hence easterly along the center of the Southern Pacific Railroad tracks to the east city limits; hence following the southern city limits boundaries westerly to the farthest southwest city limit; hence northly along the city limits to its intersection with Precinct No. 22; hence easterly along the city boundary to its intersection with Precinct No. 96. ~~to the southern boundary of Ward I.~~

Ward III is hereby declared to include all of that property of the city that lies east of the following described line: Beginning at the north end of Main Street in the city of Albany; hence southerly along the centerline of Main Street to the intersection of the centerlines of Main Street and Salem Avenue; hence easterly along the centerline of Salem Avenue to the center of Periwinkle Creek; hence southerly along the center of Periwinkle Creek to the centerline of Pacific Boulevard; hence westerly along the centerline of Pacific Boulevard to a point which would be formed at the centerline of Thurston Street if it was extended to cross Pacific Boulevard; hence southerly along the centerline of Thurston Street to the intersection of the centerline of Queen Avenue; hence easterly along Queen Avenue to the centerline of Geary Street; hence southerly along Geary Street to the center of the Santiam Canal; hence easterly along the center of the Santiam

Canal to the centerline of Columbus Street; hence southerly along the centerline of Columbus Street to the Southern Pacific Railroad tracks; hence easterly along the Southern Pacific Railroad tracks to the city limits.
