

ORDINANCE NO. 5031

AN ORDINANCE AMENDING ORDINANCE NO. 5024, WHICH LEVIED AN ASSESSMENT AGAINST PROPERTY SPECIFICALLY BENEFITTED BY THE REMOVAL OR CUTTING OF NOXIOUS WEEDS AND VEGETATION PURSUANT TO THE ALBANY MUNICIPAL CODE SECTIONS 7.84.100 - 7.84.130, PROVIDING FOR THE DOCKETING OF ASSESSMENTS AS CITY LIENS AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: That Ordinance No. 5024 is hereby amended so as to amend the amount assessed against the property for the removal of noxious weeds and vegetation and abatement of nuisance as referred to in Ordinance No. 5024 as follows:


