

ORDINANCE NO. 5043

AN ORDINANCE TO LEVY AN ASSESSMENT AGAINST PROPERTY SPECIFICALLY BENEFITED BY A SEWER CONNECTION AND THE ASSESSMENT OF A SYSTEMS DEVELOPMENT CHARGE AT: 2694 POPLAR STREET NW, 2597 SQUIRE STREET NW, 3290 KINGSTON WAY NW, 2746 GIBSON HILL ROAD NW, 1338 NORTH ALBANY ROAD NW, 3057 CREST LOOP NW, 2301 ROBINHOOD LANE NW, 2480 ROBINHOOD LANE NW, 2475 ROBINHOOD LANE NW, 2690 OAK GROVE LOOP NW, 2365 ROBINHOOD LANE NW, 3230 KINGSTON WAY NW, 758 LAUREL PLACE NW, 2700 ROBINHOOD LANE NW, ALBANY; AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: The sewer systems development charge as referred to in this ordinance is to provide a sewer connection to serve the structure located on the property described as follows:

Section 2: The sewer systems development charge and the assessment for the same shall be levied according to the provisions of Albany Municipal Code, Chapter 15.16.

Section 3: The total cost of the sewer systems development charge is as follows:


Section 4: The City Recorder is hereby directed to enter a statement of the assessment as above provided in the docket of the city liens and give notice thereof as provided by law.

Section 5: Inasmuch as this ordinance is necessary for the immediate preservation of the peace, health and safety of the City of Albany, Oregon, an emergency is hereby declared to exist; and this ordinance shall be in full force and effect immediately upon passage by the Council and approval by the Mayor.
