AN ORDINANCE LEVYING A CHARGE UNDER THE PROVISIONS OF CHAPTER 10.16 OF THE ALBANY MUNICIPAL CODE FOR AN IN-LIEU-OF ASSESSMENT FOR INTERCEPTOR SEWERS FOR SAID PROPERTY BEING DESCRIBED AS TAX LOT NO. 400, OF PARCEL 10S-04W-35DD; AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Said charges are for the purpose of a property outside the original North Albany Sanitary Sewer Assessment District to receive benefit from the existing sewer in the North Albany Sewer Basin as required under Chapter 10.16 of the Albany Municipal Code (AMC). Said property is located within the Interceptor Basin as described in the Final Engineer's Report, dated April 13, 1993, and as a result of the completion of the 12th Avenue Sanitary Sewer project, SS-01-09, has requested connection to the city sewer service by plumbing permit application. The charge made by this ordinance is for an In-lieu-of Interceptor Sewer assessment for a property outside the original sewer district that has been issued a permit to connect to the sewer, AMC 10.16.100 (Ordinance 5048).

Section 2: The total cost for service from the sanitary sewer line serving the property described in Section 1 is as follows:

\$2,024 (Interceptor Rate - Properties Outside District) x .31 Acres = \$627.44

Note: The Interceptor Sewer rate levied against 12th Avenue sanitary sewer residents were established in July 2000 by Resolution No. 4275 and AMC 10.16.110.

Section 3: Inasmuch as this ordinance is necessary for the immediate preservation of the peace, health, and safety of the citizens of the City of Albany, an emergency is hereby declared to exist; and this ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
