AN ORDINANCE AMENDING ORDINANCE NOS. 5040, 5041, 5511, SEGREGATING THE SEWER SYSTEM DEVELOPMENT CHARGE, SEWER ASSESSMENT, AND COLLECTOR SEWER IN-LIEU OF ASSESSMENT ON PROPERTY OWNED BY MATHIAS J AND MARJEAN HELLMAN AND DESCRIBED AS TAX LOT NO. 1200, OF PARCEL 10S-03W-31CC; AND DECLARING AN EMERGENCY.
