

DESIGNATING TYPE OF RAILROAD CROSSING TO BE MAINTAINED

WHEREAS, Ordinance No. 2854 provides that the City Council shall, by resolution, designate the type of railroad crossing that should be maintained by the railroads within the City of Albany, said railroad crossing being designated Type A and Type B under Section 1 of Ordinance No. 2854, and Type C under Section 1 of Ordinance No. 3005 which amends Ordinance No. 2854.

WHEREAS, all railroad crossings designated within the City of Albany have been duly examined by a committee appointed for that purpose by the Mayor and City Council and their recommendations having been given due consideration, it is hereby

RESOLVED by the Common Council of the City of Albany that the types of railroad crossings to be maintained within the City of Albany are as follows:

* It is intended that the railroad crossings as described shall be extended to the proposed curb lines as designated by the City.

The Committee further recommends that the S. P. & S. Railroad Company be directed to improve the traveled surface of Water Street in the railroad track area from Main St. to Madison St.

The Committee also wished to recommend that when Water Street is improved from Madison St. to Lyon St. that the definition of Type A railroad crossings be specified for the installation of the paving adjacent to the tracks.

The Committee further recommends that the specifications for Type A railroad crossings be applied to all of the tracks on Water Street between Ferry St. and Lyon St. and that the necessary reconstruction be required to comply with such specifications.

BE IT FURTHER RESOLVED that the following crossings are in an extremely rough and hazardous condition and that the railroad companies be directed to repair these crossings in accordance with specifications adopted by the City Council within the immediate future and that the companies submit a schedule of repairs to the City within the next ninety days:
