

RESOLUTION NO. 2554

RESOLUTION ESTABLISHING THE RATES FOR THE COLLECTION OF REFUSE INSIDE THE ALBANY CITY LIMITS AND REPEALING RESOLUTION NO. 2412.

WHEREAS, rates for the collection of refuse in the city shall be set by resolution as specified in Albany Municipal Code Chapter 3.28.

NOW, THEREFORE, BE IT RESOLVED that the Albany City Council has established the following rates for the purpose of refuse collection with the city of Albany:

Residential & Commercial Can Service Rates. Rates to be charged by a franchisee for the collection of refuse in the city shall not exceed those established by the following schedule:

	Effective September 1, 1983	August 1, 1985
First can (32-gallon or less)..... (collected once weekly)	\$5.25	\$4.80
Second can.....	3.50	2.90
Each additional can.....	3.50	2.90
Minimum charge for extra service not on route..	2.90	2.50

The charge for occasional additional pickup of refuse removed from yards or buildings shall be a reasonable charge for each pickup and such additional charge as the size and nature of the particular articles to be hauled will justify.

Commercial Container Service Rates. Rates to be charged by a franchisee for the collection of refuse and rubbish in the city shall not exceed those established by the following schedule:


