A RESOLUTION APPROPRIATING \$475,000 FROM ALBANY RURAL FIRE PROTECTION DISTRICT; APPROVING EXEMPTION FROM THE COMPETITIVE BIDDING REQUIREMENTS THROUGH A CONTRACT WITH HGACBUY AND PIERCE MANUFACTURING, INC.; ISSUING A NOTICE OF INTENT TO AWARD CONTRACT WITH PIERCE MANUFACTURING, INC.; AND AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH PIERCE MANUFACTURING, INC. NOT TO EXCEED \$850,000 TO PURCHASE A NEW LADDER TRUCK.

WHEREAS, Oregon Local Budget Law provides that expenditures in the year of receipt of grants, gifts, bequests or devices transferred to the local government in trust for a specific purpose may be made after enactment of a resolution or ordinance authorizing the expenditure, ORS 294.338(2); and

WHEREAS, the Albany Rural Fire Protection District contributed \$475,000 toward the purchase of a new ladder truck for the Fire Department; and

WHEREAS, HGACBuy (Houston-Galveston Area Council Cooperative Purchasing Program) conducted a formal, competitive Request for Proposal process for the purchase of a ladder truck substantially identical to the specification needs identified by the Fire Department; and

WHEREAS, HGACBuy allows local government access to competitively bid contracts for emergency vehicles, pursuant to ORS279A.220 and OAR 137-046-0400 to 0480; and

WHEREAS, purchasing ladder trucks through a contract with HGACBuy and Pierce Manufacturing, Inc. would not reduce competition or give favoritism; and

WHEREAS, the Fire Department is prepared to issue a Notice of Intent to award the purchase of a new ladder truck; and

WHEREAS, the Notice of Intent has to be advertised seven days prior to awarding the purchase; and

WHEREAS, if the City does not receive any formal protests to the Notice of Intent, the City Manager may award the purchase of the new ladder truck to Pierce Manufacturing, Inc.

NOW, THEREFORE, BE IT RESOLVED that the Albany City Council appropriates a \$475,000 contribution from Albany Rural Fire Protection District from the Capital Replacement Fund for the purchase of a new ladder truck; and

BE IT FURTHER RESOLVED that the Albany City Council authorizes the Fire Department an exemption from the competitive bidding process for the purchase of a new ladder truck through HGACBuy and Pierce Manufacturing, Inc.; and

BE IT FURTHER RESOLVED that the Albany City Council authorizes the Fire Department to issue a Notice of Intent to award a contract to Pierce Manufacturing, Inc.; and

BE IT FURTHER RESOLVED that the Albany City Council authorizes the City Manager to enter into a contract not to exceed \$850,000 with Pierce Manufacturing, Inc. to purchase a new ladder truck, subject to no formal protests during the seven-day required notice period.

It is agreed that the manufacturer's statement of origin ("MSO") for the Product covered by this Agreement shall remain in the possession of Pierce until the entire Purchase Price has been paid. If more than one Product is covered by this Agreement, then the MSO for each individual Product shall remain in the possession of Pierce until the Purchase Price for that Product has been paid in full. In case of any default in payment, Pierce may take full possession of the Product, and any payments that have been made shall be applied as payment for the use of the Product up to the date of taking possession.
- 16. <u>Independent Contractors</u>. The relationship of the parties established under this Agreement is that of independent contractors and neither party is a partner, employee, agent, or joint venturer of or with the other.
- 17. <u>Assignment</u>. Neither party may assign its rights and obligations under this Agreement unless it has obtained the prior written approval of the other party.
- 18. Governing Law; Jurisdiction. Without regard to any conflict of laws provisions, this Agreement is to be governed by and under the laws of the state of Wisconsin.
- 19. <u>Facsimile Signatures</u>. The delivery of signatures to this Agreement by facsimile transmission shall be binding as original signatures.
- 20. Entire Agreement. This Agreement shall be the exclusive agreement between the parties for the Product. Additional or different terms proposed by the Customer shall not be applicable, unless accepted in writing by Pierce's authorized representative. No change in, modification of, or revision of this Agreement shall be valid unless in writing and signed by Pierce's authorized representative.
- 21. <u>Conflict</u>. In the event of a conflict between the Customer Specifications and the Pierce Proposal, the Pierce Proposal shall control. In the event there is a conflict between the Pierce Proposal and this Agreement, the Pierce Proposal shall control.
- 22. <u>Signatures</u>. This Agreement is not effective unless and until it is approved, signed and dated by Pierce Manufacturing, Inc.'s authorized representative.
