
NOW, THEREFORE, BE IT RESOLVED by the Albany City Council that it does hereby accept this right-of-way dedication deed.

# Exhibit B - Right-of-Way Dedication Map



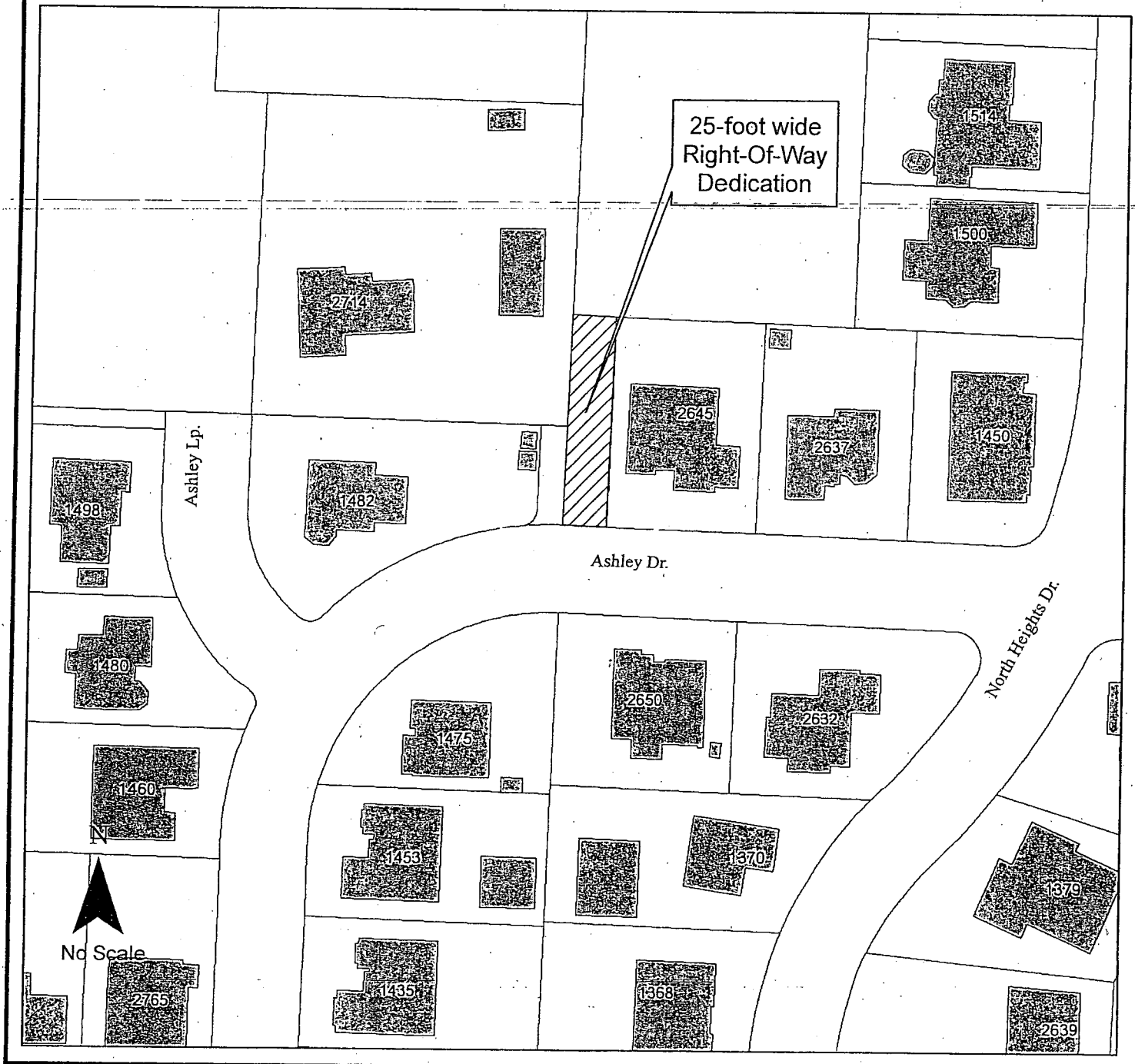
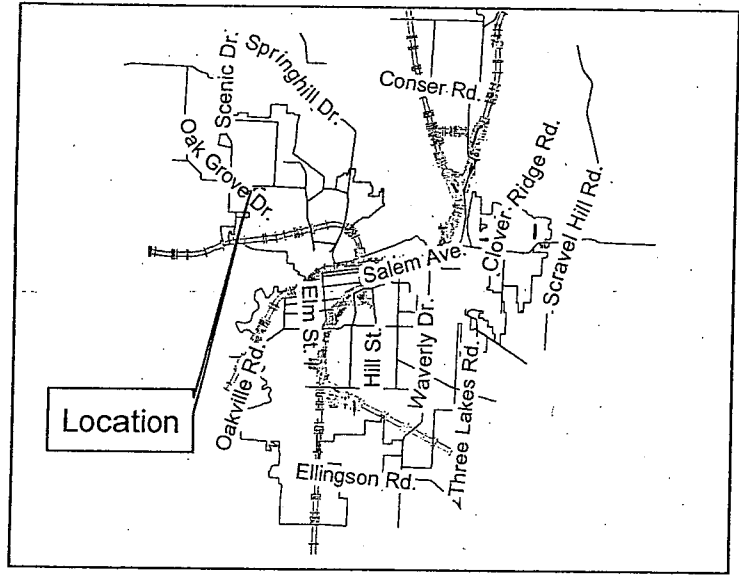
