
Legal Description for Thurston Street Right-of-Way dedication adjacent to Sunrise School and Sunrise Park


The Northernmost 753.23 feet of the property conveyed to the City of Albany by a 1967 deed recorded in Linn County, Oregon Deed Records Book 325, Page 609, lying over Linn County Oregon Assessors tax lot 11S03W07-DC-04902, and a portion of Linn County Assessors tax lot 11S03W18-AB-00101, City of Albany, Linn County, Oregon, more particularly described as follows;

Beginning at a point at the existing south terminus of the Thurston Street right-of-way, said point lying on the west line of the Thurston Street right-of-way line, 25 feet south of the south right-of-way line of 20<sup>th</sup> Avenue SE; thence South 1°30' East 753.23 feet along the west property line of that property described in the aforementioned deed to a point 35.11 feet South of the Northeast corner of Lot 3, Block 2 of Thurston Manor subdivision; thence North 88°30' East 50.0 feet to the east line of the aforementioned property; thence North 1°30' West 583.93 feet along the east line of the aforementioned property to an angle point in the property's east property line; thence North 88°30' East 10.0 feet along the property line of the aforementioned property to an angle point in the property's east property line; thence North 1°30'West 169.3 feet along the east property line of the aforementioned property to the south terminus of the Thurston Street right-of-way, said point lying on the east right-of-way line of Thurston Street; thence South 88°30' West 60.0 feet along the south line of the Thurston Street right-of-way to the Point of Beginning. The right-of-way being dedicated is as shown on the attached maps labeled Exhibits B and C, attached hereto and incorporated herein by this reference.

The basis of bearings of this description is the deed recorded in Linn County Oregon deed records Book 325, Page 609.
