Exhibit A

Legal Description for Chicago Street right-of-way dedication

A variable width right-of-way dedication along the westernmost 13.32 feet to 15.13 feet of the property described in Linn County Oregon Deed Reference # 2021-1767, more particularly described below.

Beginning at the southwest corner of Lot 7 of Perlenfein Estates, said point lying on the east right-of-way line of Chicago Street;

thence south 98 feet parallel to and 52 feet east of the west right-of-way line of Chicago Street, to the north property line of Lot 5, Block 1, Ruraldale Addition, said point lying 2 feet east of the northwest corner of said Lot 5, Block 1, Ruraldale Addition;

thence west 2 feet along the north line of Lot 5, Block 1, Ruraldale Addition, to the northwest corner said Lot 5, Block 1, Ruraldale Addition;


thence continuing west along the right-of-way line of Chicago Street 11.32 feet to the southwest corner of that property described in Linn County Oregon Deed Reference # 2021-1767, said point also being an interior corner of the Chicago Street right-of-way;

thence north 98 feet along the west property line of that property described in Linn County Oregon Deed Reference # 2021-1767, said line also being the east right-of way line of Chicago Street, to the northwest corner of that property described in Linn County Oregon Deed Reference # 2021-1767, said corner also being an interior corner of the Chicago Street right-ofway;

thence east 15.13 feet along the north line of that property described in Linn County Oregon Deed Reference # 2021-1767, said line also being the right-of-way line of Chicago Street, to the Point of Beginning.

Exhibit B - Map of right-of-way dedication




