#### Call to Order

Chair Mel Huffman called the meeting to order at 3:30 p.m.

#### Approval of August 21, 2025, Minutes

3:30 p.m.

Chuck Kratch moved to approve the August minutes as presented, Matthew Arck seconded the motion, and the motion passed the commission 4-0.

#### 2026 Airport Advisory Commission Meeting Schedule

3:31 p.m.

The 2026 meetings will be held every other month at 3:30 p.m., beginning January 15, 2026, unless a special meeting is called to address urgent business.

Staff Updates 3:32 p.m.

Transportation Manager Robb Romeo provided updates on several ongoing airport projects, including the replacement of the fuel card reader, Bipartisan Infrastructure Law (BIL) funded hangar re-roofing, follow-up on the Precision Approach Path Indicator (PAPI) and runway lighting inspection. He also discussed the CORE Grant application, summer maintenance activities, and an upcoming sewer infrastructure project that will involve boring under the runway.

FBO Updates 3:38 p.m.

Tony Hann reported on the hangar heater installation, a possible water leak, fuel terminal installer search, new security cameras, winter aircraft relocation, Salem airport's overnight parking fee, gate/fence issues, and future service expansion by the in-house mechanic.

#### **Business from the Commission**

3:50 p.m.

JR Beroncal inquired about an airport revenue report, citing concerns about sustainability and potential closure. Romeo responded that a fiscal and economic development study is in progress, with a final report expected by year-end and no later than March 2026. Huffman emphasized the need to operate the airport like a business and shared ideas for economic development.

Matthew Arck exchanged emails with Matt Harrington regarding the airport's social media presence and scheduled an in-person meeting to discuss steps toward creating accounts on platforms such as Facebook

and Instagram and clarify legal and regulatory requirements for public facing content with the goal to begin developing a social media presence to promote the airport. He also plans to speak with Steven Hodges, who runs <u>flyalbanyoregon.com</u> as a private citizen, to learn more about his plans and explore potential collaboration.

Huffman renewed interest in gaining an additional 500 feet of usable runway, discussing funding, FAA restrictions, and potential economic benefits. The commission contributed additional ideas to improve the airport, including student support, a café or food truck, business development incentives, and infrastructure improvements.

Public Comment 4:18 p.m.

Dan Miltenberger noted graffiti on a jet and under the small doors, suggesting it be painted over to improve the airport's appearance. He also emphasized the importance of including all airport users, such as pilots and tenants, in the upcoming Economic Development Survey, as past efforts were viewed as incomplete. He also shared a brief history of the south runway extension, explaining how volunteer efforts and timely coordination during scheduled work allowed the city to asphalt a prepared area for just \$14,000, avoiding extra mobilization costs. He recommended using similar strategies in future projects to reduce expenses.

Kratch proposed adding a date to the new Albany Municipal Airport sign, and the group agreed to include "Established 1929" to reflect its municipal designation, even though the airfield originally opened for private use in 1920.
